- 1. I am an attorney for Martin G. McNulty, and as such have personal knowledge of the facts and matters hereinafter deposed to by me.
- 2. I swear this affidavit in response to the October 1, 2014 Affidavit of Paula Render (the "Render Affidavit").

- 3. Paragraph 6 of the Render Affidavit addresses a December 3, 2013 letter I sent to The Honourable John D. Ground, in which I recounted a conversation with Ms. Render wherein she indicated that Arctic Glacier would be amenable to choosing a claims adjudicator based in the United States. The December 3, 2013 letter is attached to the Monitor's Eighteenth Report.

In my email to Ms. Render I advised that "[b]ased on Dan [Kotchen]'s and my recollection of our conversation, my letter was accurate and the record does not need to be corrected."
