We expect our suppliers to operate fair and ethical workplaces, where workers are treated with integrity and we require a written commitment from our subcontractors that they are and must not be engaged in the use of slavery or human trafficking. A&M reserves the right to refuse to engage suppliers or subcontractors that cannot demonstrate compliance with the values of eradication of modern slavery and human trafficking.

While A&M continues to grow, maintaining quality and upholding our core values are ever-constant, strategic priorities. As part of this we will continue to monitor whether enough is being done to support our zero tolerance approach to modern slavery and human trafficking.
