UPON THE APPLICATION of the Royal Bank of Canada (the "Lender") in respect of Sprague-Rosser Contracting Co. Ltd., Sprague-Rosser Developments Inc. and Pacific Federation Equity Group inc. (collectively, the "Debtor"); AND UPON reading the Application, and the Affidavit of Gary Ivany dated July 29, 2014, filed or be filed; AND UPON reading the consent of Alvarez & Marsal Canada Inc. to act as receiver and manager ("Receiver") of the Debtor, filed; AND UPON the Court being advised that the Receiver does not intend to cause the Debtor to perform any further work in respect of the construction projects identified in Schedule "A" to this Order (the "Projects" or "Bonded Contracts"); AND UPON the Court being satisfied that in the circumstances the method for service on the Debtor and on the various interested parties is good, sufficient and should be validated; AND UPON hearing counsel for the Lender and any other interested parties that may be present;

IT IS HEREBY ORDERED AND DECLARED THAT:

SERVICE

The time for service of the notice of application for this order is hereby abridged and service 1. thereof is deemed good and sufficient.

APPOINTMENT

Pursuant to section 243 of the Bankruptcy and Insolvency Act, RSC 1985, c B-3 ("BIA"), section 2. 13(2) of the Judicature Act. RSA 2000, c J-2, and s 65(7) of the Personal Property Security Act, RSA 2000, c P-7, Alvarez & Marsal Canada Inc. is hereby appointed Receiver, without security, of all of the Debtor's current and future assets, undertakings and properties of every nature and kind whatsoever, and wherever situate, including all proceeds thereof (the "Property").

RECEIVER'S POWERS

- The Receiver is hereby empowered and authorized, but not obligated, to act at once in respect of 3. the Property and, without in any way limiting the generality of the foregoing, the Receiver is hereby expressly empowered and authorized to do any of the following where the Receiver considers it necessary or desirable:
 - to take possession and control of the Property and any and all proceeds, receipts and (a) disbursements arising out of or from the Property:
 - to receive, preserve and protect the Property, or any part or parts thereof, including, but (b) not limited to, the changing of locks and security codes, the relocating of Property to safeguard it, the engaging of independent security personnel, the taking of physical inventories and the placement of such insurance coverage as may be necessary or desirable:
 - to manage, operate and carry on the business of the Debtor, including the powers to (c) enter into any agreements, incur any obligations in the ordinary course of business. cease to carry on all or any part other business, or cease to perform any contracts of the Debtor:
 - to engage consultants, appraisers, agents, experts, auditors, accountants, managers, (d) counsel and such other persons from time to time and on whatever basis, including on a temporary basis, to assist with the exercise of the powers and duties, including without limitation those conferred by this Order;
 - to purchase or lease machinery, equipment, inventories, supplies, premises or other (e) assets to continue the business of the Debtor or any part or parts thereof;
 - to receive and collect all monies and accounts now owed or hereafter owing to the Debtor (f) and to exercise all remedies of the Debtor in collecting such monies, including, without limitation, to enforce any security held by the Debtor;
 - to settle, extend or compromise any indebtedness owing to or by the Debtor; (g)
 - to execute, assign, issue and endorse documents of whatever nature in respect of any of (h) the Property, whether in the Receiver's name or in the name and on behalf of the Debtor, for any purpose pursuant to this Order;
 - to undertake environmental or workers' health and safety assessments of the Property (i) and operations of the Debtor;
 - to initiate, prosecute and continue the prosecution of any and all proceedings and to (j) defend all proceedings now pending or hereafter instituted with respect to the Debtor, the Property or the Receiver, and to settle or compromise any such proceedings. The authority hereby conveyed shall extend to such appeals or applications for judicial review in respect of any order or judgment pronounced in any such proceeding, and provided

further that nothing in this Order shall authorize the Receiver to defend or settle the action in which this Order is made unless otherwise directed by this Court;

- to market any or all the Property, including advertising and soliciting offers in respect of (k) the Property or any part or parts thereof and negotiating such terms and conditions of sale as the Receiver in its discretion may deem appropriate;
- to sell, convey, transfer, lease or assign the Property or any part or parts thereof out of (1) the ordinary course of business,
 - without the approval of this Court in respect of any transaction not exceeding \$500,000, provided that the aggregate consideration for all such transactions does not exceed \$1,000,000; and
 - with the approval of this Court in respect of any transaction in which the purchase (ii) price or the aggregate purchase price exceeds the applicable amount set out in the preceding clause.

and in each such case notice under subsection 60(8) of the Personal Property Security Act, RSA 2000, c P-7 shall not be required.

- to apply for any vesting order or other orders (including without limitation, confidentiality (m) or sealing orders) necessary to convey the Property or any part or parts thereof to a purchaser or purchasers thereof, free and clear of any liens or encumbrances affecting such Property:
- to report to, meet with and discuss with such affected Persons (as defined below) as the (n) Receiver deems appropriate all matters relating to the Property and the receivership, and to share information, subject to such terms as to confidentiality as the Receiver deems advisable:
- to register a copy of this Order and any other Orders in respect of the Property against (0) title to any of the Property;
- to apply for any permits, licences, approvals or permissions as may be required by any (p) governmental authority and any renewals thereof for and on behalf of and, if thought desirable by the Receiver, in the name of the Debtor,
- to enter into agreements with any trustee in bankruptcy appointed in respect of the (p) Debtor, including, without limiting the generality of the foregoing, the ability to enter into occupation agreements for any property owned or leased by the Debtor;
- to exercise any shareholder, partnership joint venture, or other rights which the Debtor **(r)** may have:
- upon the application of the Receiver to this Court upon notice to all affected and **(s)** interested parties, and where the Court is of the opinion on the making of such an application that it is proper and in the best interests of the estate, to assign the Debtor into bankruptcy or obtain a bankruptcy order against the Debtor; and
- to take any steps reasonably incidental to the exercise of these powers or the (t) performance of any statutory obligations;

and in each case where the Receiver takes any such actions or steps, it shall be exclusively authorized and empowered to do so, to the exclusion of all other Persons (as defined below), including the Debtor, and without interference from any other Person.

DUTY TO PROVIDE ACCESS AND CO-OPERATION TO THE RECEIVER

40.0ZO4a37a

- (i) The Debtor, (ii) all of its current and former directors, officers, employees, agents, accountants, 4. legal counsel and shareholders, and all other persons acting on its instructions or behalf, and (iii) all other individuals, firms, corporations, governmental bodies or agencies, or other entities having notice of this Order (all of the foregoing, collectively, being "Persons" and each being a "Person") shall forthwith advise the Receiver of the existence of any Property in such Person's possession or control, shall grant immediate and continued access to the Property to the Receiver, and shall deliver all such Property (excluding Property subject to liens the validity of which is dependant on maintaining possession) to the Receiver upon the Receiver's request.
- All Persons shall forthwith advise the Receiver of the existence of any books, documents, 5. securities, contracts, orders, corporate and accounting records, and any other papers, records and information of any kind related to the business or affairs of the Debtor, and any computer programs, computer tapes, computer disks, or other data storage media containing any such information (the foregoing, collectively, the "Records") in that Person's possession or control, and shall provide to the Receiver or permit the Receiver to make, retain and take away copies thereof and grant to the Receiver unfettered access to and use of accounting, computer, software and physical facilities relating thereto, provided however that nothing in this paragraph 5 or in paragraph 6 of this Order shall require the delivery of Records, or the granting of access to Records, which may not be disclosed or provided to the Receiver due to the privilege attaching to solicitor-client communication or documents prepared in contemplation of litigation or due to statutory provisions prohibiting such disclosure.
- if any Records are stored or otherwise contained on a computer or other electronic system of 6. information storage, whether by independent service provider or otherwise, all Persons in possession or control of such Records shall forthwith give unfettered access to the Receiver for the purpose of allowing the Receiver to recover and fully copy all of the information contained therein whether by way of printing the information onto paper or making copies of computer disks or such other manner of retrieving and copying the information as the Receiver in its discretion deems expedient, and shall not alter, erase or destroy any Records without the prior written consent of the Receiver. Further, for the purposes of this paragraph, all Persons shall provide the Receiver with all such assistance in gaining immediate access to the information in the Records as the Receiver may in its discretion require including providing the Receiver with instructions on the use of any computer or other system and providing the Receiver with any and all access codes, account names and account numbers that may be required to gain access to the information.

NO PROCEEDINGS AGAINST THE RECEIVER

No proceeding or enforcement process in any court or tribunal (each, a "Proceeding"), shall be 7. commenced or continued against the Receiver except with the written consent of the Receiver or with leave of this Court.

NO PROCEEDINGS AGAINST THE DEBTOR OR THE PROPERTY

No Proceeding against or in respect of the Debtor or the Property shall be commenced or 8. continued except with the written consent of the Receiver or with leave of this Court and any and all Proceedings currently under way against or in respect of the Debtor or the Property are hereby stayed and suspended pending further Order of this Court, provided, however, that nothing in this Order shall: (i) prevent any Person from commencing a proceeding regarding a claim that might otherwise become barred by statute or an existing agreement if such proceeding is not -5-

commenced before the expiration of the stay provided by this paragraph 8; and (ii) affect a Regulatory Body's investigation in respect of the debtor or an action, suit or proceeding that is taken in respect of the debtor by or before the Regulatory Body, other than the enforcement of a payment order by the Regulatory Body or the Court. "Regulatory Body" means a person or body that has powers, duties or functions relating to the enforcement or administration of an Act of Parliament or of the legislature of a province.

NO EXERCISE OF RIGHTS OR REMEDIES

Subject to paragraphs 33 to 36 of this Order, all rights and remedies (Including, without limitation, set-off rights) against the Debtor, the Receiver, or affecting the Property, are hereby stayed and suspended except with the written consent of the Receiver or leave of this Court, provided however that this stay and suspension does not apply in respect of any "eligible financial contract" (as defined in the BIA), and further provided that nothing in this paragraph shall (i) empower the Receiver or the Debtor to carry on any business which the Debtor is not lawfully entitled to carry on, (ii) exempt the Receiver or the Debtor from compliance with statutory or regulatory provisions relating to health, safety or the environment, (iii) prevent the filing of any registration to preserve or perfect a security interest, or (iv) prevent the registration of a claim for ilen.

NO INTERFERENCE WITH THE RECEIVER

No Person shall discontinue, fail to honour, alter, interfere with, repudiate, terminate or cease to 10. perform any right, renewal right, contract, agreement, licence or permit in favour of or heid by the Debtor, without written consent of the Receiver or leave of this Court. Nothing in this Order shall prohibit any party to an eligible financial contract from closing out and terminating such contract in accordance with its terms.

CONTINUATION OF SERVICES

11. All Persons having oral or written agreements with the Debtor or statutory or regulatory mandates for the supply of goods and/or services, including without limitation, all computer software, communication and other data services, centralized banking services, payroll services, insurance, transportation services, utility or other services to the Debtor are hereby restrained until further Order of this Court (or alternatively, until receiving written permission of the Receiver, which the Receiver may choose in its discretion to provide) from discontinuing, altering, interfering with or terminating the supply of such goods or services as may be required by the Receiver, and this Court directs that the Receiver shall be entitled to the continued use of the Debtor's current telephone numbers, facsimile numbers, Internet addresses and domain names, provided in each case that the normal prices or charges for all such goods or services received after the date of this Order are paid by the Receiver in accordance with normal payment practices of the Debtor or such other practices as may be agreed upon by the supplier or service provider and the Receiver, or as may be ordered by this Court.

RECEIVER TO HOLD FUNDS

12. All funds, monies, cheques, instruments, and other forms of payments received or collected by the Receiver from and after the making of this Order from any source whatsoever, including without limitation the sale of all or any of the Property and the collection of any accounts receivable in whole or in part, whether in existence on the date of this Order or hereafter coming into existence, shall be deposited into one or more new accounts to be opened by the Receiver (the "Post Receivership Accounts") and the monles standing to the credit of such Post Receivership Accounts from time to time, net of any disbursements provided for herein, shall be held by the Receiver to be paid in accordance with the terms of this Order or any further order of this Court.

EMPLOYEES

- Subject to employees' rights to terminate their employment, all employees of the Debtor shall 13. remain the employees of the Debtor until such time as the Receiver, on the Debtor's behalf, may terminate the employment of such employees. The Receiver shall not be liable for any employee-related liabilities, including any successor employer liabilities as provided for in section 14.06(1.2) of the BIA, other than such amounts as the Receiver may specifically agree in writing to pay, or in respect of its obligations under sections 81.4(5) or 81.6(3) of the BIA or under the Wage Earner Protection Program Act, SC 2005, c 47 ("WEPPA").
- Pursuant to clause 7(3)(c) of the Personal Information Protection and Electronic Documents Act, 14. SC 2000, c 5, the Receiver shall disclose personal information of identifiable individuals to prospective purchasers or bidders for the Property and to their advisors, but only to the extent desirable or required to negotiate and attempt to complete one or more sales of the Property (each, a "Sale"). Each prospective purchaser or bidder to whom such personal information is disclosed shall maintain and protect the privacy of such information and limit the use of such information to its evaluation of the Sale, and if it does not complete a Sale, shall return all such information to the Receiver, or in the alternative destroy all such information. The purchaser of any Property shall be entitled to continue to use the personal information provided to it, and related to the Property purchased, in a manner which is in all material respects identical to the prior use of such information by the Debtor, and shall return all other personal information to the Receiver, or ensure that all other personal information is destroyed.

LIMITATION ON ENVIRONMENTAL LIABILITIES

- Notwithstanding anything in any federal or provincial law, the Receiver is not personally 15. liable in that position for any environmental condition that arose or environmental damage that occurred:
 - before the Receiver's appointment; or (i)
 - after the Receiver's appointment unless it is established that the condition arose (ii) or the damage occurred as a result of the Receiver's gross negligence or wilful misconduct.
 - Nothing in sub-paragraph (a) exempts a Receiver from any duty to report or make (b) disclosure imposed by a law referred to in that sub-paragraph.
 - (¢) Notwithstanding anything in any federal or provincial law, but subject to sub-paragraph (a) hereof, where an order is made which has the effect of requiring the Receiver to remedy any environmental condition or environmental damage affecting the Property, the Receiver is not personally liable for failure to comply with the order, and is not personally liable for any costs that are or would be incurred by any person in carrying out the terms of the order.
 - if, within such time as is specified in the order, within 10 days after the order is (i) made if no time is so specified, within 10 days after the appointment of the Receiver, if the order is in effect when the Receiver is appointed, or during the period of the stay referred to in clause (a) below, the Receiver:
 - Α. complies with the order, or
 - В. on notice to the person who issued the order, abandons, disposes of or otherwise releases any interest in any real property affected by the condition or damage;

- during the period of a stay of the order granted, on application made within the (II) time specified in the order referred to in clause (i) above, within 10 days after the order is made or within 10 days after the appointment of the Receiver, if the order is in effect when the Receiver is appointed, by,
 - the court or body having jurisdiction under the law pursuant to which the A. order was made to enable the Receiver to contest the order; or
 - the court having jurisdiction in bankruptcy for the purposes of assessing В. the economic viability of complying with the order; or
- if the Receiver had, before the order was made, abandoned or renounced or (111) been divested of any interest in any real property affected by the condition or damage.

Nothing in this Order shall derogate from the protection afforded to the Receiver by section 14.06 of the BIA, any other applicable legislation, or the common law.

LIMITATION ON RECEIVER'S LIABILITY

Except for gross negligence or wilful misconduct, as a result of its appointment or carrying out the 16. provisions of this Order the Receiver shall incur no liability or obligation that exceeds an amount for which it may obtain full indemnity from the Property. Nothing in this Order shall derogate from any limitation on liability or other protection afforded to the Receiver under any applicable law, including, without limitation, Section 14.06, 81.4(5) or 81.6(3) of the BIA.

RECEIVER'S ACCOUNTS

- The Receiver and counsel to the Receiver shall be paid their reasonable fees and disbursements, in each case, incurred at their standard rates and charges. The Receiver and counsel to the Receiver shall be entitled to and are hereby granted a charge (the "Receiver's Charge") on the Property, as security for such fees and disbursements, incurred both before and after the making of this Order in respect of these proceedings, and the Receiver's Charge shall form a first charge on the Property in priority to all security interests, trusts, deemed trusts, liens, charges and encumbrances, statutory or otherwise, in favour of any Person but subject to section 14.06(7). 81.4(4) and 81.6(2) of the BIA.
- 18. The Receiver and its legal counsel shall pass their accounts from time to time.
- Prior to the passing of its accounts, the Receiver shall be at liberty from time to time to apply 19. reasonable amounts, out of the monies in its hands, against its fees and disbursements, including the legal fees and disbursements, incurred at the normal rates and charges of the Receiver or its counsel, and such amounts shall constitute advances against its remuneration and disbursements when and as approved by this Court.

FUNDING OF THE RECEIVERSHIP

20. The Receiver is at liberty and is hereby empowered to borrow by way of a revolving credit or otherwise from the Plaintiff, such monies from time to time as it may consider necessary or desirable, provided that the outstanding principal amount does not exceed \$500,000 (or such greater amount as this Court may by further Order authorize) at any time, at such rate or rates of interest as it deems advisable for such period or periods of time as it may arrange, for the purpose of funding the exercise of the powers and duties conferred upon the Receiver by this Order, including Interim expenditures. The whole of the Property shall be and is hereby charged by way of a fixed and specific charge (the "Receiver's Borrowings Charge") as security for the

payment of the monies borrowed, together with interest and charges thereon, in priority to all security interests, trusts, deemed trusts, liens, charges and encumbrances, statutory or otherwise, in favour of any Person, but subordinate in priority to the Receiver's Charge and the charges set out in sections 14.06(7), 81.4(4) and 81.6(2) of the BIA.

- Neither the Receiver's Borrowings Charge nor any other security granted by the Receiver in 21. connection with its borrowings under this Order shall be enforced without leave of this Court.
- The Receiver is at liberty and authorized to issue certificates substantially in the form annexed as 22. Schedule "B" hereto (the "Receiver's Certificates") for any amount borrowed by it pursuant to this Order.
- The monies from time to time borrowed by the Receiver pursuant to this Order or any further 23. order of this Court and any and all Receiver's Certificates evidencing the same or any part thereof shall rank on a pari passu basis, unless otherwise agreed to by the holders of any prior issued Receiver's Certificates.

ALLOCATION

Any interested party may apply to this Court on notice to any other party likely to be affected, for 24. an order allocating the Receiver's Charge and Receiver's Borrowings Charge amongst the various assets comprising the Property.

GENERAL

- The Receiver may from time to time apply to this Court for advice and directions in the discharge 25. of its powers and duties hereunder.
- 26. Notwithstanding Rule 6.11 of the Alberta Rules of Court, unless otherwise ordered by this Court, the Receiver will report to the Court from time to time, which reporting is not required to be in affidavit form and shall be considered by this Court as evidence. The Receiver's reports shall be filed by the Court Clerk notwithstanding the same not including an original signature.
- 27. Nothing in this Order shall prevent the Receiver from acting as a trustee in bankruptcy of the Debtor.
- 28. This Court hereby requests the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada or in the United States to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All courts, tribunals, requiatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order or to assist the Receiver and its agents in carrying out the terms of this Order.
- 29. The Receiver be at liberty and is hereby authorized and empowered to apply to any court. tribunal, regulatory or administrative body, wherever located, and including in particular the courts of the Province of Saskatchewan, for the recognition of this Order and for assistance in carrying out the terms of this Order and that the Receiver is authorized and empowered to act as a representative in respect of the within proceedings for the purpose of having these proceedings recognized in a jurisdiction outside Canada.
- 30. The Plaintiff shall have its costs of this Application, up to and including entry and service of this Order, provided for by the terms of the Plaintiff's security or, if not so provided by the Plaintiff's security, then on a substantial indemnity basis to be paid by the Receiver from the Debtor's estate with such priority and at such time as this Court may determine.

RIGHTS OF THE SURETY

- Nothing in this Order shall be construed or deemed to affect or interfere in any way with the right 33. and ability of Western Surety Company (the "Surety") to attend on or investigate the Projects and Bonded Contracts, including without limitation, obtaining copies of documents and information from all or any of the Defendants, the Receiver or from any obligee or claimant as those terms are defined in the bonds, in regard to the Projects and Bonded Contracts, which documents and information shall include but not be limited to contracts, subcontracts, purchase orders, plans and specifications related to the Projects or the Bonded Contracts.
- The stay and suspension of rights and remedies against all or any one of the Defendants, the 34. Receiver or affecting the Property Imposed by any provision of this Order, (other than in respect of the Surety taking any action to signify, collect or otherwise attorn accounts owing by any obligee to the Debtor under a Project or Bonded Contract), does not apply to the Surety and to the owners of the Projects to the extent such rights or remedies arise from bonds granted by the Surety in relation to Projects or from the Bonded Contracts provided that nothing herein shall be considered to affect or alter the ownership or priority of any person to funds in relation to any Projects or Bonded Contracts or any contracts in relation thereto, or entitle the Surety to use any funds arising from the Projects or Bonded Contracts or any contracts in relation thereto otherwise owing to all or any of the Defendants to complete work in respect of the Projects or Bonded Contracts or otherwise without prior notice to and consent of the Receiver or further Order of this Honourable Court on application made with notice to the Receiver as provided for herein. The Surety shall, at the request of the Receiver, provide periodic updates as to the status of a Project or Bonded Contract and, in any event, the Surety shall provide a final accounting to the Receiver within thirty (30) days following the completion of each Project.
- 35. The Receiver shall provide notice to and account to the Surety for any monies or accounts received or collected by the Receiver in respect of a Bonded Contract and shall deposit any such monies or accounts received into a separate Interest bearing account and shall not apply or use the funds in any way without prior notice to and consent of the Surety or further order of the Court.
