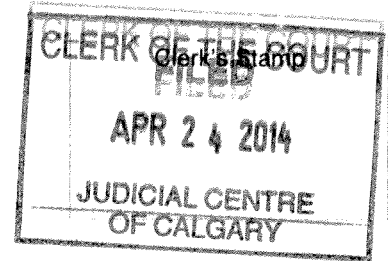

UPON THE APPLICATION of Alvarez & Marsal Canada Inc. (the "**Receiver**"), in its capacity as court appointed receiver of Do All Industries Ltd. and P&O Assets Ltd. (collectively referred to as, the "**Debtors**") pursuant to the order issued by Justice A.D. Macleod in the within proceedings on February 6, 2014, (the "**Receivership Order**") under the *Bankruptcy and Insolvency Act* (Canada) (the "**BIA**"); **AND UPON** having read the fourth report of the Receiver dated April 18, 2014 (the "**Fourth Receiver's Report**"), and the pleadings and proceedings filed herein; **AND UPON** noting the Affidavit of Service of Marcia Smith, sworn April 23, 2014 **AND UPON** hearing from counsel for the Receiver, and from any other affected parties that may be present;

IT IS HEREBY ORDERED AND DECLARED THAT:

SERVICE:

1. The time for service of the Application and the Fourth Receiver's Report for this Order is hereby abridged and deemed good and sufficient and this Application is properly returnable today.

APPROVAL OF TRANSACTION:

2. The Offer and Sale Agreement (the "**Agreement**"), dated March 26, 2013, between Alco Energy Industries Ltd. (the "**Purchaser**") and the Receiver, in its capacity as receiver of the assets, properties and undertakings of the Debtors for, *inter alia*, the purchase and sale of the Assets (attached hereto as Schedule "**A**" and as defined in the Agreement) be and is hereby approved and ratified.

3. The Receiver is hereby authorized to conclude the transactions contemplated by the Agreement (collectively, the "**Transactions**") and to take all such steps and execute all such documents as may reasonably be necessary to complete the Transactions, and the Receiver and the Purchaser are further authorized to make non-material amendments to the Agreement as may be agreed to by the Receiver and the Purchaser.

4. The Receiver is hereby expressly authorized and directed to:

- (a) perform the covenants in the Agreement, substantially in accordance with its terms, subject to such amendments as the Receiver and the Purchaser may agree to; and,
- (b) execute all deeds and documents, and to take all such steps as may be necessary or advisable in the Receiver's sole discretion to consummate the Transactions.

5. The Transactions shall not be void or voidable at the instance of Claimants (as defined below) and shall not constitute nor shall be deemed to be a settlement, fraudulent preference, assignment, fraudulent conveyance or other challengeable or reviewable transaction under the *Bankruptcy and Insolvency Act* (Canada), the *Fraudulent Preference Act* (Alberta) or any other applicable federal or provincial legislation, and the Transactions, or any actions taken in connection therewith, shall not constitute conduct meriting an oppression remedy.

VESTING OF THE ASSETS

6. Upon closing of the Transactions, all of the Debtors' right, title and interest, in and to the Assets shall, without further instrument of transfer or assignment, vest in the Purchaser as contemplated by the Agreement, absolutely and forever, free and clear of and from any and all claims by, through, or under the Debtors, and any and all estate, right, title, interest, and liens, including but not limited to, claims, hypothecs, mortgages, charges, liens (whether contractual, statutory or otherwise), security interests, assignments, actions, levies, taxes, judgments, writs of execution, trusts or deemed trusts (whether contractual, statutory or otherwise), options, agreements, disputes, debts, encumbrances or other rights, limitations or restrictions of any nature whatsoever including, without limitation, any rights or interests of any creditors of the Debtors whether or not they have attached or been perfected, registered or filed, whether secured or unsecured or otherwise, whether liquidated, unliquidated or contingent (all of the foregoing being collectively referred to hereinafter as, the "**Claims**") whether such Claims came into existence prior to, subsequent to, or as a result of any previous order of this Court, by or of all persons or entities of any kind whatsoever, including, without limitation, all individuals, firms, corporations, partnerships, joint ventures, trusts, unincorporated organizations, governmental and administrative bodies, agencies, authorities or tribunals and all other natural persons or corporations, whether acting in their capacity as principals or as agents, trustees, executives, administrators or other legal representatives including for greater certainty and without limiting the generality of the foregoing: (i) the Claims held by or in favour of the individuals and entities served (either directly or through their solicitors) with this Application; and (ii) the beneficiary of any Claims created or provided for pursuant to any previous Order of this Court in these proceeding (collectively, the "**Claimants**").

7. Upon the delivery of a certified copy of this Order to the Registrar of the Alberta Land Titles Office (the "**Registrar**"), the Registrar shall:

- (a) cancel the existing certificates of title to the lands identified in Schedule "A" to this Order (the "**Lands**");
- (b) issue new certificates of title to the Lands in the name of the Purchaser or his/her nominee (the "**New Titles**") which shall include the encumbrances listed in Schedule "B" to this Order (collectively, the "**Permitted Encumbrances**"); and

- (c) discharge any and all of the encumbrances from the New Titles that are listed in Schedule "C" to this Order (collectively, the "**Discharged Encumbrances**").

8. The Register shall perform the various requirements in this Order:

- (a) in the order specified in paragraph 7 of this Order; and,
- (b) notwithstanding the requirements of section 191(1) of the *Land Titles Act*, RSA 2000, c. L 4 (the "**LTA**").

9. Upon the Registrar completing the steps identified in paragraphs 7 and 8 of this Order, the Registrar shall forthwith make available to the Purchaser, or the Purchaser's counsel, a certified copy of the New Titles.

10. Nothing in this Order shall prejudice any person's *in personam* claim against the Debtors.

HOLDING AND DISTRIBUTION OF PROCEEDS

11. The Receiver shall hold the total proceeds paid to it pursuant to the Agreement, less usual closing costs including real estate commissions, legal fees and taxes (the "**Net Proceeds**") pursuant to and in accordance with the terms of this Order.

12. The Receiver shall distribute the Net Proceeds, less the amount of builders' liens registered against the Lands, to the National Bank of Canada ("**NBC**") on account of the secured indebtedness owing by the Debtors to NBC.

13. The remaining proceeds held by the Receiver after the distribution contemplated by paragraph 12 of this Order (the "**Remaining Proceeds**"), shall stand in place of the Lands and any holder of any Claims may assert their Claims against the Remaining Proceeds with the same right and priority that the holder of the Claim had against the Lands, immediately prior to the sale of the Lands, as if the Lands had not been sold and remained in the possession and control of P&O Assets Ltd.

14. The Receiver be and is hereby authorized to make additional distributions to NBC from the estate of Do All Industries Ltd. until such time as the indebtedness owed by Do All Industries Ltd. to NBC has been indefeasibly repaid in full.

SEALING OF THE CONFIDENTIAL APPENDIX

15. Part 6, Division 4 of the Alberta Rules of Court does not apply to the Application and the Clerk of the Court is hereby directed to seal Appendixes "B" and "C" to the Fourth Receiver's Report (collectively, the "**Confidential Appendix**") on the Court file for a period of one hundred and eighty (180) days from the date of this Order. The Confidential Appendix shall be sealed and filed in an envelope containing the following endorsement thereon:

THIS ENVELOPE CONTAINS THE CONFIDENTIAL APPENDIX TO THE FOURTH RECEIVER'S REPORT. THE FOURTH RECEIVER'S REPORT IS SEALED FOR A PERIOD OF ONE HUNDRED AND EIGHTY (180) DAYS PURSUANT TO AN ORDER ISSUED BY THE HONOURABLE JUSTICE JEFFREY DATED APRIL 24, 2014, AND IS NOT TO BE PLACED ON THE PUBLIC RECORD OR MADE PUBLICALLY ACCESSIBLE.

16. Any person may apply, on reasonable notice to the Receiver and any other persons likely to be affected, to vary or amend the terms of paragraph 15 of this Order.

17. Paragraph 16 of the Receivership Order be and is hereby amended by adding the following to the end of the first sentence of paragraph 16 of the Receivership Order:

"...that is in the Receiver's possession and control at the time that a claim is made against the Receiver."

18. Service of this Order by email, facsimile, registered mail, courier or personal delivery to the persons listed on the Service List shall constitute good and sufficient service of this Order, and no persons other than those listed on the Service List are entitled to be served with a copy of this Order.

19. The Receiver is at liberty to reapply for further advice, assistance and direction as may be necessary to give full force and effect to the terms of this Order.
