Davis LLP pay to NC Power Systems Company, or its counsel, the sum of \$55,606.00 from the net proceeds (the "Proceeds") of the Gator Tug (as defined in the Sixth Report) as at the date of the Sixth Report plus a per diem of \$19.26 thereafter in complete satisfaction of its claims against the Gator Tug and the Proceeds;
- 4. following the payment referenced above, Davis LLP shall remit all of the remaining Proceeds to the Receiver to be disbursed in accordance with further orders of this Court; and
