Name of applicant: Alvarez & Marsal Canada Inc.

TAKE NOTICE that an application will be made by the applicant, Alvarez & Marsal Canada Inc. ("A&M"), the Receiver-Manager of Pakit Inc. ("Pakit" or the "Company") before The Honourable Mr. Justice Burnyeat at the Vancouver Courthouse at 800 Smithe Street, Vancouver, British Columbia on Thursday, March 8, 2012 at 9:00 a.m. for an Order as set out in Part 1 below and in the form attached hereto.

Part 1: ORDER(S) SOUGHT

- 1. abridging the time for service of this Notice of Application and supporting materials;
- 2. approving the activities of A&M as Receiver-Manager of Pakit as set out in the Receiver's First Report to the Court dated March 1, 2012 and Second Report to Court to be filed:
- 3. approving and outlining the procedure for the sale of the property, assets and undertaking of the Company; and
- 4. increasing the borrowing powers of the Receiver-Manager to allow it to borrow up to the sum of \$2,500,000 based upon the security of Receiver's Certificates.

Part 2: FACTUAL BASIS

- 1. On July 12, 2011, the Company filed a Notice of Intention to make a Proposal (the "NOI"), which was converted into a proceeding in the Supreme Court of British Columbia, Vancouver Registry, Action No. S-115028 (the "CCAA Proceedings") under the *Companies' Creditors Arrangement Act* (the "CCAA") pursuant to the order granted by this Honourable Court on July 28, 2011 (the "Initial Order"). A&M was appointed as Monitor in the CCAA Proceeding pursuant to the Initial Order.
- 2. The Initial Order provided for, among other things, an initial stay of proceedings against the Company until and including August 25, 2011, or such later date as ordered by this Honourable Court (the "**Stay Period**"). Subsequent Orders were granted that extended the Stay Period until January 31, 2012.
- 3. The Company is the parent company of Pakit USA Company Inc. ("Pakit US") and Pakit International Trading Company ("Pakit International"). Pakit International is the parent company of Packaging International Technology Sweden AB ("PIT"), a company incorporated under the laws of Sweden.
- 4. Pakit is in the business of developing clean technology solutions for the packaging industry. The commercial proprietary product of Pakit and its subsidiaries and affiliates is the "Pakit100 Machine" and various related patents.
- 5. The Company is indebted to a number of creditors. The principal creditor of the Company is Fairfax Financial Holdings Limited ("Fairfax") which is owed approximately \$6 million.
- 6. On February 2, 2012, A&M was appointed as Receiver-Manager (the "Receiver") in this proceeding of all of the property, assets and undertaking of the Company on the application of Fairfax.
- 7. The Receiver has determined that it is in the best interest of all stakeholders of the Company to sell all of the property, assets and undertaking of the Company.

- 8. The Receiver proposes certain bidding procedures in order to realize the highest possible price for the property, assets and undertaking of the Company.
- 9. In order to continue the operation of the Company until the sale takes place the Receiver will need borrowings of up to a total of \$2,500,000 to operate the business of Pakit until the third week of May or until a sale of the Collateral can be finalized.

Part 3: LEGAL BASIS

- 1. Business Corporations Act, S.B.C. 2002, c. 57;
- 2. Bankruptcy and Insolvency Act, R.S.C. 1985, c. B-3;
- 3. Law and Equity Act, R.S.B.C. 1996, c. 253; and
- 4. The inherent jurisdiction of this Court.
