We are the counsel to Alvarez & Marsal Canada Inc., the court-appointed monitor in the above-captioned CCAA proceedings (the "**Monitor**"). Please find enclosed an unredacted, unfiled copy of the Monitor's Third Report dated April 30, 2014. We wish to advise Your Ladyship of the following:

- 1. A redacted copy of the Third Report, unfiled, was provided to the Service List on April 30, 2014. The purpose for the redaction is that certain of the information in the Receipts and Disbursement section of the Third Report are subject to a sealing order that was granted by the Honourable Mr. Justice A.D. Macleod on March 4, 2014 (specifically, information relating to the sale proceeds that were derived from the sale of certain assets). Counsel for Alston will be applying to lift the sealing order now that the transaction to which the sealing order relates has closed and we have advised the Service List that, upon granting of the order lifting the ceiling order, the unredacted Third Report will be filed and served;
- 2. At the time of preparing the Third Report, the Monitor had not yet been advised by ATB of its intention to oppose the extension of the stay of proceedings and to cross-apply for the appointment of a receiver and manager. The Monitor has advised Alston and ATB that it will not be amending or supplementing the Third Report. The Monitor is considering whether any additional submissions to the contents of the Third Report are required, save the fact that the Monitor now makes no recommendation with respect to the application by Alston for an extension of the stay nor with respect to the forthcoming application of ATB to appoint a receiver manager.
