**AFFIDAVIT**

I, Cecilia Conto, Paralegal of 1600 – 925 West Georgia Street, in the City of Vancouver, in the Province of British Columbia, SWEAR THAT:

1. I am a paralegal at Lawson Lundell LLP, counsel for the Petitioner, 1392752 B.C. Ltd., and as such, have personal knowledge of the facts and matters hereinafter deposed to, save and except where the same is stated to be made upon information and belief, and, as to such facts, I verily believe the same to be true.
2. Unless otherwise defined, capitalized terms herein have the same meaning as in the Petition to the Court filed September 8, 2023.
3. The Grid Promissory Note dated January 31, 2023 (the "First Note") provides that advances made pursuant to the First Note bear interest at 5% per annum, calculated and compounded in accordance with the terms of the First Note. The Grid Promissory Note dated May 31, 2023 (the "Second Note") provides that advances made pursuant to the

Second Note bear interest at 8% per annum, calculated and compounded in accordance with the terms of the Second Note.

4. Exhibits A, B and C to my affidavit are printouts for interest calculations I performed.
5. Relying on the amounts recorded as advanced pursuant to the First Note, attached and marked as **Exhibit "A"** is a copy of the interest calculations with respect to the First Note. The total amount of interest payable on all advances set out in the First Note to February 29, 2024 is \$69,953.52.
6. Relying on the amounts recorded as advanced pursuant to the Second Note, attached and marked as **Exhibit "B"** is a copy of the interest calculations with respect to the Second Note. The total amount of interest payable on all advances, less repayments, as set out in the Second Note to February 29, 2024 is \$373,719.47.
7. Pursuant to the Receiver's Certificate No.1, dated September 21, 2023,(the "**Receiver's Certificate**") the principal amount of \$300,000 bears interest at a rate of 6% per annum above prime rate of Bank of Montreal from time to time. Attached and marked collectively as **Exhibit "C"** is a true copy of the Receiver's Certificate and corresponding interest calculations. The total amount of interest payable on this amount to February 29, 2024 is \$17,999.21.
8. Attached and marked as **Exhibit "D"** is a copy of the land title searches as at January 2, 2023 with respect to the lands owned by the Respondent, ROC Holdings Ltd.
9. Attached and marked as **Exhibit "E"** is a copy of a search of the B.C. Personal Property dated January 2, 2023, for the Respondent Skeena Sawmills Ltd.





THIS IS TO CERTIFY that Alvarez & Marsal Canada Inc. the Receiver (the "**Receiver**") of all of the assets, undertakings and property of Skeena Sawmills Ltd., Skeena Bioenergy Ltd. and ROC Holdings Ltd.
