- I, Arad Mojtahedi, of 2700 1133 Melville Street, Vancouver, British Columbia, Lawyer, AFFIRM THAT:
- 1. I am a lawyer at DLA Piper (Canada) LLP ("DLA"), counsel to Alvarez & Marsal Canada Inc., court appointed Receiver and Manager of Quarry Rock Developments (McAllister) Inc. and Quarry Rock Developments (McAllister) Limited Partnership (the "Receiver") in these proceedings, and as such have personal knowledge of the facts and matters hereinafter deposed to save and except where the same are stated to be made upon information and belief and where so stated I verily believe them to be true.
- 2. The accounts of DLA issued to the Monitor for service from April 1, 2024 to December 31, 2024 can be summarized as follows:

- 3. The fees and disbursements set out above were necessarily incurred in fulfilling the instructions of the Receiver and have been approved by the Receiver.
- 4. In addition to the above fees, between January 1, 2025 and today, DLA has incurred approximately \$10,000 in fees, taxes and disbursements and estimates a further amount of \$16,800 in fees. taxes and disbursements to complete these receivership proceedings and any ancillary works in connection with a potential bankruptcy of the Debtors.
- 5. The services comprised in the accounts of DLA set out above relate to:
 - (a) reviewing and revising the Receiver's reports;
 - (b) assisting the Receiver on matters related to the sales process;
 - drafting the service agreement between the Receiver and VC Management Inc. in respect of ongoing site monitoring and maintenance;
 - (d) reviewing various legal documents, including various offers to purchase and the additional bids received pursuant to PD-62;
 - (e) preparing for and attending in Court on applications, including the sale approval application, which was opposed by various parties;
 - (f) correspondence and communication with the Receiver and other parties involved in the receivership; and
 - (g) reviewing and opining on the validity of Canadian Western Bank's security over the Debtors' assets.

6. The total cumulative time comprised in the accounts of DLA as of December 31, 2024 is approximately 154 hours broken down as follows:
