ON THE APPLICATION OF the voting members of the BC Tree Fruits Cooperative (the "**Members**") coming on for hearing at Vancouver, British Columbia, on the 28th day of April, 2025; AND ON HEARING Mary Buttery, K.C., counsel for the Members, and those other counsel listed on **Schedule "A"** hereto, and no one else appearing although duly served, AND UPON READING the material filed; AND PURSUANT TO the *Companies' Creditors Arrangement Act*, R.S.C. 1985 c. C-36, as amended (the "**CCAA**"), the British Columbia *Supreme Court Civil Rules*, and the inherent jurisdiction of this Court;

THIS COURT ORDERS AND DECLARES THAT:

1. Paragraph 9 of the Order Made After Application (Representation Order) granted in these proceedings on August 26, 2024, is hereby amended, removing the \$100,000 maximum on amounts the Petitioners are authorized to pay for the reasonable fees and disbursements of the Members' representative legal counsel, Osler, Hoskin & Harcourt LLP, ("**Representative Counsel**"). Instead, the maximum amount of such payments to Representative Counsel shall be limited only by the reasonable discretion of the court-appointed monitor, Alvarez & Marsal Canada Inc., in consultation with the Petitioners.

2. Endorsement of this Order by counsel appearing on this application other than counsel for the Members is hereby dispensed with.




