ON THE APPLICATION OF Amarjit Singh Lalli (the "Members' Representative"), in his capacity as representative of the voting members (the "Members") of the BC Tree Fruits Cooperative ("BCTFC"), coming on for hearing at Vancouver, British Columbia, on this day; AND ON HEARING Mary Buttery, K.C. and Christian Garton, counsel for the Members' Representative, and those other counsel listed on <u>Schedule "A"</u> hereto, and no one else appearing, AND PURSUANT TO the *Companies' Creditors Arrangement Act*, R.S.C. 1985 c. C-36, as amended (the "CCAA"), the British Columbia *Supreme Court Civil Rules*, and the inherent jurisdiction of this Court;

THIS COURT ORDERS AND DECLARES THAT:

1. The Monitor is hereby authorized and directed to disclose to Osler, Hoskin & Harcourt LLP (the "Members' Representative Counsel") in its capacity as representative counsel to the Members, the relative distributions, expressed as a percentage, that each current and former

member of BCTFC is expected to receive of any surplus funds of BCTFC remaining after payment of all creditors and professional costs associated with these proceedings, as calculated and presented by BCTFC and based on BCTFC's current rules, along with any details concerning the methodology of calculating such relative entitlements (collectively, the "Personal Information").

- 2. The Members' Representative Counsel and the Members' Representative, in his capacity as the representative of the Members, shall use the Personal Information for the sole purpose of the consideration and evaluation by the Members of a potential alternative transaction proposed by Wildstone Capital Ltd. concerning the assets that are the subject matter of the approval and vesting order made in these proceedings on May 16, 2025 (the "**Purpose**"), and shall limit the use and disclosure of such Personal Information to and for the Purpose.
- 3. Notwithstanding anything to the contrary herein, the Members' Representative Counsel and the Members' Representative shall only be permitted to disclose any part of the Personal Information to Members, and in each such case shall only disclose to a Member that of the Personal Information which pertains to such Member.

4. Endorsement of this Order by counsel appearing on this application other than the Members' Representative Counsel is hereby dispensed with.
