Johnston of the Court of King's Bench of Alberta, Judicial District of Calgary (the "Court") dated October 22, 2024, Alvarez & Marsal Canada Inc. was appointed as the receiver (the "Receiver") in respect of the marketing and sale of Viceroy Canadian Resources Corp.'s (the "Debtor") right, title and interest in and to the Amended and Restated Farm in Participation Agreement effective as of January 31, 2019 and amended and restated June 19, 2020.
