("Sanovest"), coming on for 23 Jav 2015 hearing at Vancouver, British Columbia on this date, AND ON HEARING Kibben Jackson and Jessica Cameron, counsel for Sanovest, Scott H. Stephens and Lily Zhang, counsel for 599315 B.C. Ltd. ("599") and Daniel Matthews, Peter Rubin and Encina Roh, counsel for Alvarez & Marsal Canada Inc. (the "Receiver") in its capacity as the receiver of certain assets of the Respondents, and no one else appearing, although duly served; AND UPON READING the materials filed, including Affidavit #1 of Tian Kusumoto, made May 22, 2024, Affidavit #3 of Tian Kusumoto, made May 29, 2025, the Supplemental Affidavit of Tian Kusumoto, made June 16, 2025, the Confidential Supplemental Affidavit of Tian Kusumoto, made June 23, 2025 (the "**Confidential Affidavit**"), Affidavit #1 of Suzanne Volkow, made May 16, 2024, Affidavit #3 of Suzanne Volkow, made May 30, 2025, and the unfiled Reports of the Receiver dated October 25, 2024, December 2, 2024, December 20, 2024, April 14, 2025 and June 5, 2025;

THIS COURT ORDERS AND DECLARES THAT:

- The three applications filed by Sanovest in the within proceedings on June 16 and 17, 2025 (collectively the "Sanovest Applications") are hereby be adjourned peremptorily to be heard by Justice Walker on Thursday July 3, 2025 at 10:00 am.
- 2. Until such time as the Sanovest Applications are heard, the Resort Partnership shall not:
 - (a) enter into or affirm any agreements out of the ordinary course of business, including with DLA Piper (Canada) LLP in relation to its representation of the Respondent Ecoasis Resort and Gol LLP in the Hotel Arbitration (as that term is defined in the Confidential Affidavit); and
 - (b) Sell any assets out of the ordinary course of business or sell rounds of golf beyond the 2025 season.
- 3. 599 and Daniel Matthews shall forthwith pay to Sanovest its costs of the within hearing, as agreed to or as assessed, payable as costs thrown away in any event of the cause.
