## Grounds for making this application:

#### Approval Sale and Vesting

- 4. The Alvarez & Marsal Canada Inc. (the "Receiver") was appointed the receiver of Voice Construction OPCO ULC, Voice Management Ltd., Voice Construction Ltd., Voice Construction., Earth & Energy Construction Ltd., Voice Holdings Ltd., and 2012442 Alberta Ltd. (collectively, the "Debtor") by an Order of this Honourable Court dated June 25, 2019 (the "Receivership Order").
- 5. The Receivership Order authorizes the Receiver to, among other things:
  - (a) Market any or all of the personal property (collectively called the "Property") of the Debtor (and to solicit offers in respect of such Property or any part or parts thereof), in accordance with Paragraph 3(k)
  - Negotiate the terms and conditions of a sale of Property of the Debtor in accordance with Paragraph 3(k) thereof;
  - (c) Sell, convey, transfer, lease or assign the Property or any part or parts thereof out of the ordinary course of business with the approval of this Honourable Court; and
  - (d) Apply for any Vesting Orders necessary to convey the Property or any part or parts thereof to a purchaser free and clear of any liens and encumbrances in accordance with Paragraph 3(m) thereof.
- 6. As set out in the Third Report of the Receiver, the Receiver has received and accepted an auction proposal for the Assets from GDAA.
- 7. The Receiver is of the view that the GDAA Proposal is fair and reasonable, and that acceptance of the GDAA Proposal and completing of the transaction contemplated by the GDAA Proposal is in the best interest of the Debtor, its creditors, and other stakeholders.

(the "Debtor") for an order approving the Auction Proposal (the "Sale Agreement") between the Receiver and G.D. Auction & Appraisal Inc. ("GDAA") dated September 17, 2019 and appended in the Confidential Appendices (the "Confidential Appendices to the Third Report") the Third Report of the Receiver dated September 23, 2019 (the "Third Report"), proposing the sale of the Debtor's right, title and interest in and to the assets described in Schedule "A" attached hereto (collectively, the "Assets" and each an "Asset") and the auction of the Assets in accordance with the Sale Agreement; AND UPON HAVING READ the Receivership Order dated June 25, 2019 (the "Receivership Order"), the Third Report and the Confidential Appendices to the Third Report; the Bench Brief of the Receiver dated September 23, 2019; and the Affidavit of Service; AND UPON hearing from counsel for the Receiver and such other that appeared, if any, although properly served as appears from the Affidavit of Service, filed:

## IT IS HEREBY ORDERED AND DECLARED THAT:

#### SERVICE

1. Service of notice of this application and supporting materials is hereby declared to be good and sufficient, no other person is required to have been served with notice of this application and time for service of this application is abridged to that actually given.

#### ACTIVITIES OF THE RECEIVER

2. The activities of the Receiver as described in the Second Report are hereby approved.

## APPROVAL OF TRANSACTION

- 3. This Court hereby approves and ratifies the execution of the Sale Agreement, with such minor amendments as the Receiver may deem necessary.
- 4. The Receiver and GDAA are hereby authorized to take all such steps and execute all such documents as may reasonably be necessary to conclude the transactions contemplated by the Sale Agreement (the "Transactions" and each a "Transaction") and the Receiver and GDAA are hereby authorized to execute and deliver such additional, related an ancillary documents and assurances governing or giving effect to the Transactions, as the Receiver and GDAA, in their discretion, may deem reasonably necessary or advisable to conclude the Transactions. Without in any way restricting the scope of the foregoing, the Receiver is authorized to deliver to GDAA one or more general conveyances and/or specific conveyances signed by the Receiver.
- This Court orders that any requirement of the Receiver and GDAA to issue notices under Section
  60 of the Personal Property Security Act, R.S.A. 2000, c. P-7 is hereby dispensed with.
- 6. GDAA is authorized to market and sell the Assets in accordance with the terms of the Sale Agreement.
- 7. Upon GDAA receiving the proceeds of sale from the Assets which are to be paid to the Receiver in accordance with the Sale Agreement (the "Net Sale Proceeds"), all such proceeds shall

immediately be impressed with a charge in favour of the Receiver and shall be held in trust for the benefit of the Receiver until such time as the Net Sale Proceeds are received by the Receiver. While held by GDAA, the Net Sale Proceeds shall be held in a separate trust account for the benefit of the Receiver.

#### VESTING OF PROPERTY

- 8. Upon GDAA paying to the Receiver the Net Sale Proceeds together with an accounting for same and delivery of a Receiver's Certificate to GDAA substantially in the form set out in Schedule "B" hereto (the "Receiver's Closing Certificate"), all of the Debtor's right, title and interest in and to the Assets in Schedule "A" shall vest absolutely in the name of the person or persons acquiring the Assets (collectively, the "Purchasers" and each a "Purchaser"), free and clear of and from any and all caveats, security interests, hypothecs, pledges, mortgages, liens, trusts or deemed trusts, reservations of ownership, royalties, options, rights of pre-emption, privileges, interests, assignments, actions, judgements, executions, levies, taxes, writs of enforcement, charges, or other claims, whether contractual, statutory, financial, monetary or otherwise, whether or not they have attached or been perfected, registered or filed and whether secured, unsecured or otherwise (collectively, "Claims") including, without limiting the generality of the foregoing:
  - (a) any encumbrances or charges created by the Receivership Order;
  - (b) any charges, security interests or claims evidenced by registrations pursuant to the *Personal Property Security Act* (Alberta) or any other personal property registry system;
  - (c) any liens or claims of lien under the Builders' Lien Act (Alberta); and
  - (d) those Claims listed in Schedule "C" hereto (all of which are collectively referred to as the "Encumbrances", which term shall not include the permitted encumbrances, caveats, interests, easements, and restrictive covenants listed in Schedule "D" (collectively, "Permitted Encumbrances"))

Upon delivery of the Receiver's Closing Certificate, and upon filing of a certified copy of this Order, together with any applicable registration fees, all governmental authorities including those referred to below in this paragraph (collectively, "Governmental Authorities") are hereby authorized, requested and directed to accept delivery of such Receiver's Closing Certificate and certified copy of this Order as though they were originals and to register such transfers, interest authorizations, discharges and discharge statements of conveyance as may be required to convey to the Purchasers clear title to the Assets subject only to Permitted Encumbrances. Without limiting the foregoing:

- (a) the Registrar of the Alberta Personal Property Registry shall and is hereby directed to forthwith cancel and discharge any registrations at the Alberta Personal Property Registry (whether made before or after the date of this Order) claiming security interests (other than Permitted Encumbrances) in the estate or interest of the Debtor in any of the Assets which are of a kind prescribed by applicable regulations as serial-number goods; and
- (b) the Registrar of the British Columbia Personal Property Registry shall and is hereby directed to forthwith cancel and discharge any registrations at the British Columbia Personal Property Registry (whether made before or after the date of this Order) claiming security interests (other than Permitted Encumbrances) in the estate or interest of the Debtor in any of the Assets which are of a kind prescribed by applicable regulations as serial-number goods.
- 10. Without limiting the forgoing, the Receiver shall be permitted to cancel and discharge any registrations at the Alberta Personal Property Registry and the British Columbia Personal Property Registry (whether made before or after the date of this Order) claiming security interests (other than Permitted Encumbrances) in the estate or interest of the Debtor in any of the Assets which are of a kind prescribed by applicable regulations as serial-number goods.
- 11. In order to effect the transfers and discharges described above, this Court directs each of the Governmental Authorities to take such steps as are necessary to give effect to the terms of this Order and the Sale Agreement. Presentment of this Order and the Receiver's Closing Certificate shall be the sole and sufficient authority for the Governmental Authorities to make and register transfers of title or interest and cancel and discharge registrations against any of the Assets of any Claims including Encumbrances but excluding Permitted Encumbrances.
- 12. No authorization, approval or other action by and no notice to or filing with any governmental authority or regulatory body exercising jurisdiction over the Assets is required for the due execution, delivery and performance by the Receiver of the Sale Agreement.
- 13. For the purposes of determining the nature and priority of Claims, Net Sale Proceeds (to be held in an interest bearing trust account by the Receiver) shall stand in the place and stead of the Assets from and after delivery of the Receiver's Closing Certificate and all Claims including Encumbrances (but excluding Permitted Encumbrances) shall not attach to, encumber or otherwise form a charge, security interest, lien, or other Claim against the Assets and may be

asserted against the Net Sale Proceeds with the same priority as they had with respect to the Assets immediately prior to the sale, as if the Assets had not been sold and remained in the possession or control of the person having that possession or control immediately prior to the sale. Unless otherwise ordered (whether before or after the date of this Order), the Receiver shall not make any distributions to creditors of net proceeds from sale of the Assets without further order of this Court, provided however the Receiver may apply any part of such net proceeds to repay any amounts the Receiver has borrowed for which it has issued a Receiver's Certificate pursuant to the Receivership Order.

Except as expressly provided for in the Sale Agreement or by section 5 of the Alberta *Employment Standards Code*, the Purchaser (or its nominee) shall not, by completion of the Transactions, have liability of any kind whatsoever in respect of any Claims against the Debtor.

15. Upon completion of a Transaction, the Debtor and all persons who claim by, through or under the Debtor in respect of the Asset that is the subject of the Transaction, and all persons or entities having any Claims of any kind whatsoever in respect of the Asset, save and except for persons entitled to the benefit of the Permitted Encumbrances, shall stand absolutely and forever barred, estopped and foreclosed from and permanently enjoined from pursuing, asserting or claiming any and all right, title, estate, interest, royalty, rental, equity of redemption or other Claim whatsoever in respect of or to the Asset, and to the extent that any such persons or entities remain in the possession or control of any of the Assets, or any artifacts, certificates, instruments or other indicia of title representing or evidencing any right, title, estate, or interest in and to the Assets, they shall forthwith deliver possession thereof to the appropriate Purchaser.

- 16. A Purchaser shall be entitled to enter into and upon, hold and enjoy the Asset or Assets they purchase pursuant to the Sale Agreement, for their own respective use and benefit without any interference of or by the Debtor, or any person claiming by, through or against the Debtor.
- 17. Immediately upon closing of the Transactions, holders of Permitted Encumbrances shall have no claim whatsoever against the Receiver.
- 18. The Receiver is directed to file with the Court a copy of the Receiver's Closing Certificate forthwith after delivery thereof to GDAA.
