Remedy claimed or sought:

1. An Order, substantially in the form provided in Schedule "B:



- (a) abridging the time for service of notice of this Application to the time actually given and deeming service upon the parties served as good and sufficient service;
- (b) approving the sale and vesting title of the assets (the "Assets") attached to the form of Order as Schedule "A" in accordance with the terms of the credit bid of Maynbridge Capital Inc. as set out in Fourth Report of the Receiver October 16, 2019 (the "Fourth Report") and the Confidential Appendices 1, 2, and 3 to the Fourth Report (collectively, the "Confidential Appendices")
- (c) authorizing the Receiver to discharge all encumbrances registered against the Assets on closing of the sale of the Assets;
- (d) approving an interim distribution as described in the Fourth Report to the secured creditors holding secured interests in priority to Maynbridge Capital Inc. with respect to any of the Assets (the "Interim Distribution");
- (e) declaring that the remaining proceeds from the sale of the Assets be held by the Receiver and stand in place of the Assets until further Order of this Honourable Court in respect of distribution of the proceeds and allocation of costs against the proceeds;
- (f) declaring that certain Personal Property Registry registrations of Grande Tire Inc., and Boyd Ventures Inc. against Voice Construction Opco ULC, Voice Management Ltd., Voice Construction Ltd., Earth & Energy Construction Ltd., Voice Holdings Ltd., and 2012442 Alberta Ltd. (collectively, the "Debtor") are invalid and authorizing the Receiver to discharge said registrations;
- (g) a declaration that no amounts are owing under the Personal Property Registry registrations of GE Canada Assets Financing Holding Company, and GE VFS Canada Limited Partnership against the Debtor and authorizing the Receiver to discharge said registrations;
- (h) approving the activities of the Receiver as set out in the Fourth Report; and
- (i) declaring the Division 4 of Part 6 of the *Rules of Court* does not apply to this Application, and the Confidential Appendices be temporarily sealed until the Receiver is discharged or further Order of the Court.

Grounds for making this application:

Approval Sale and Vesting

- The Receiver was appointed the receiver of the Debtor by an Order of this Honourable Court dated June 25, 2019 (the "Receivership Order"). The Receivership Order authorizes the Receiver to, among other things;
 - (a) Market any or all of the personal property (collectively called the "Property") of the Debtor (and to solicit offers in respect of such Property or any part or parts thereof), in accordance with Paragraph 3(k);
 - (b) Negotiate the terms and conditions of a sale of Property of the Debtor in accordance with Paragraph 3(k) thereof;

- (c) Sell, convey, transfer, lease or assign the Property or any part or parts thereof out of the ordinary course of business with the approval of this Honourable Court; and
- 4. As set out in the Fourth Report and subject to court approval, the Receiver has received and accepted a credit bid offer for the Assets from Maynbridge Capital Inc. (the "Offer").
- 5. The Receiver is of the view that the Offer is fair and reasonable, and that acceptance of the Offer and completion of the transaction contemplated by the Offer is in the best interest of the Debtor, its creditors, and other stakeholders.

Interim Distribution

- 6. The Receiver has reviewed certain documents from John Deere Financial Inc., Jim Pattison Industries Ltd., Komatsu International (Canada) Inc., and ARI Financial Services Inc. (the "PMSI Creditors") and has received an opinion from its legal counsel that said creditors hold certain security interests in priority to Maynbridge Capital Inc. with respect to certain of the Assets.
- 7. The Receiver is proposing that the PMSI Creditors be paid the amounts secured by their priority registrations against the Assets from the net proceeds of the sale of the Assets in accordance with their respective priorities to the Assets.

Discharge of PPR Registrations

- 8. Grande Tire Inc. and Boyd Ventures Inc. have registered security interests at the Personal Property Registry against certain assets of the Debtor. However both have advised that they do not have security agreements with the Debtor.
- 9. GE Canada Assets Financing Holding Company and GE VFS Canada Limited Partnership (collectively "GE Canada") have registered security interests at the Personal Property Registry against "photocopiers" of the Debtor. GE Canada has advised that it has no active accounts with respect to the PPR registrations and the Debtor.
- 10. As a result, the Receiver seeks to have the above registrations discharged without payment.

Sealing Order

11. The Confidential Appendices contain confidential information of a commercial nature which, if disclosed to third parties prior to the completion of the Receiver's sales process of the Debtor's Property, could materially jeopardize the Receiver's sale process, or if the sale of the Assets does not close, could materially jeopardize the value that the Receiver is subsequently able to obtain from the sale of the Assets, and as such, it is appropriate that the Court dispense with filing the Confidential Appendices with the Clerk of the Court until the Receiver's has concluded its sale of the Property, or grant an interim Temporary Sealing Order in relation thereto.

UPON THE APPLICATION by Alvarez & Marsal Canada Inc. in its capacity as the Court-appointed receiver and manager (the "**Receiver**") of the undertakings, property and assets of Voice Construction OPCO ULC, Voice Management Ltd., Voice Construction Ltd., Earth & Energy Construction Ltd., Voice Holdings Ltd., and 2012442 Alberta Ltd. (the "**Debtor**")

for an order approving the sale transaction (the "Transaction") contemplated by an agreement of purchase and sale (the "Sale Agreement") between the Receiver and Maynbridge Capital Inc. (the "Purchaser") dated October 17, 2019 and appended in the Confidential Appendices (the "Confidential Appendices to the Fourth Report") of the Fourth Report of the Receiver dated October 16, 2019 (the "Fourth Report"), and vesting in the Purchaser (or its nominee) the Debtor's right, title and interest in and to the assets described in Schedule "A" attached hereto (collectively, the "Purchased Assets" and each an "Purchased Asset"); AND UPON HAVING READ the Receivership Order dated June 25, 2019 (the "Receivership Order"); the Order of Justice J. H. Goss granted August 13, 2019 (the "August 13, 2019 Order"), the Fourth Report and the Confidential Appendices to the Fourth Report, the Bench Brief of the Receiver dated October 16, 2019, and the Affidavit of Service;

AND UPON HEARING the submissions of counsel for the Receiver, and such other that appeared, if any, although property served as appears from the Affidavit of Service;

IT IS HEREBY ORDERED AND DECLARED THAT:

SERVICE

 Service of notice of this application and supporting materials is hereby declared to be good and sufficient, no other person is required to have been served with notice of this application and time for service of this application is abridged to that actually given.

ACTIVITIES OF THE RECEIVER

 The activities, conduct and actions of the Receiver as described in the Fourth Report are hereby approved.

APPROVAL OF TRANSACTION

3. The Transaction is hereby approved and execution of the Sale Agreement by the Receiver is hereby authorized and approved, with such minor amendments as the Receiver may deem necessary. The Receiver is hereby authorized and directed to take such additional steps and execute such additional documents as may be necessary or desirable for completion of the Transaction and conveyance of the Purchased Assets to the Purchaser (or its nominee).

VESTING OF PROPERTY

- 4. Upon delivery of a Receiver's certificate to the Purchaser (or its nominee) substantially in the form set out in Schedule "B" hereto (the "Receiver's Closing Certificate"), all of the Debtor's right, title and interest in and to the Purchased Assets shall vest absolutely in the name of the Purchaser (or its nominee), free and clear of and from any and all caveats, security interests, hypothecs, pledges, mortgages, liens, trusts or deemed trusts, reservations of ownership, royalties, options, rights of pre-emption, privileges, interests, assignments, actions, judgements, executions, levies, taxes, writs of enforcement, charges, or other claims, whether contractual, statutory, financial, monetary or otherwise, whether or not they have attached or been perfected, registered or filed and whether secured, unsecured or otherwise (collectively, "Claims") including, without limiting the generality of the foregoing:
 - (a) any encumbrances or charges created by the Receivership Order;
 - (b) any charges, security interests or claims evidenced by registrations pursuant to the *Personal Property Security Act* (Alberta) or any other personal property registry system;
 - (c) any liens or claims of lien under the Builders' Lien Act (Alberta); and
 - (d) those Claims listed in Schedule "C" hereto (all of which are collectively referred to as the "Encumbrances", which term shall not include the permitted encumbrances, caveats, interests, easements, and restrictive covenants listed in Schedule "D" (collectively, "Permitted Encumbrances"))

and for greater certainty, this Court orders that all Claims including Encumbrances other than Permitted Encumbrances, affecting or relating to the Purchased Assets are hereby expunged, discharged and terminated as against the Purchased Assets

5. Upon delivery of the Receiver's Closing Certificate, and upon filing of a certified copy of this Order, together with any applicable registration fees, all governmental authorities including those referred to below in this paragraph (collectively, "Governmental Authorities") are hereby authorized, requested and directed to accept delivery of such Receiver's Closing Certificate and certified copy of this Order as though they were originals and to register such transfers, interest authorizations, discharges and discharge

statements of conveyance as may be required to convey to the Purchaser or its nominee clear title to the Purchased Assets subject only to Permitted Encumbrances. Without limiting the foregoing:

- (a) the Registrar of the Alberta Personal Property Registry shall and is hereby directed to forthwith cancel and discharge any registrations at the Alberta Personal Property Registry (whether made before or after the date of this Order) claiming security interests (other than Permitted Encumbrances) in the estate or interest of the Debtor in any of the Purchased Assets which are of a kind prescribed by applicable regulations as serial-number goods;
- (b) the Registrar of the British Columbia Personal Property Registry shall and is hereby directed to forthwith cancel and discharge any registrations at the British Columbia Personal Property Registry (whether made before or after the date of this Order) claiming security interests (other than Permitted Encumbrances) in the estate or interest of the Debtor in any of the Purchased Assets which are of a kind prescribed by applicable regulations as serial-number goods.
- 6. Without limiting the forgoing, the Receiver shall be permitted to cancel and discharge any registrations at the Alberta Personal Property Registry and the British Columbia Personal Property Registry (whether made before or after the date of this Order) claiming security interests (other than Permitted Encumbrances) in the estate or interest of the Debtor in any of the Purchased Assets which are of a kind prescribed by applicable regulations as serial-number goods.
- 7. In order to effect the transfers and discharges described above, this Court directs each of the Governmental Authorities to take such steps as are necessary to give effect to the terms of this Order and the Sale Agreement. Presentment of this Order and the Receiver's Closing Certificate shall be the sole and sufficient authority for the Governmental Authorities to make and register transfers of title or interest and cancel and discharge registrations against any of the Purchased Assets of any Claims including Encumbrances but excluding Permitted Encumbrances.
- 8. No authorization, approval or other action by and no notice to or filing with any governmental authority or regulatory body exercising jurisdiction over the Purchased

Assets is required for the due execution, delivery and performance by the Receiver of the Sale Agreement.

- 9. Upon delivery of the Receiver's Closing Certificate together with a certified copy of this Order, this Order shall be immediately registered by the Land Titles Registrar notwithstanding the requirements of section 191(1) of the Land Titles Act, RSA 2000, c.L-7 and notwithstanding that the appeal period in respect of this Order has not elapsed. The Land Titles Registrar is hereby directed to accept all Affidavits of Corporate Signing Authority submitted by the Receiver in its capacity as Receiver of the Debtor and not in its personal capacity.
- 10. For the purposes of determining the nature and priority of Claims, net proceeds from sale of the Purchased Assets (to be held in an interest bearing trust account by the Receiver) shall stand in the place and stead of the Purchased Assets from and after delivery of the Receiver's Closing Certificate and all Claims including Encumbrances (but excluding Permitted Encumbrances) shall not attach to, encumber or otherwise form a charge, security interest, lien, or other Claim against the Purchased Assets and may be asserted against the net proceeds from sale of the Purchased Assets with the same priority as they had with respect to the Purchased Assets immediately prior to the sale. as if the Purchased Assets had not been sold and remained in the possession or control of the person having that possession or control immediately prior to the sale. Unless otherwise ordered (whether before or after the date of this Order), the Receiver shall not make any distributions to creditors of net proceeds from sale of the Purchased Assets without further order of this Court, provided however the Receiver may apply any part of such net proceeds to repay any amounts the Receiver has borrowed for which it has issued a Receiver's Certificate pursuant to the Receivership Order.
- 11. Except as expressly provided for in the Sale Agreement or by section 5 of the Alberta *Employment Standards Code*, the Purchaser (or its nominee) shall not, by completion of the Transaction, have liability of any kind whatsoever in respect of any Claims against the Debtor.
- 12. Upon completion of the Transaction, the Debtor and all persons who claim by, through or under the Debtor in respect of the Purchased Assets, and all persons or entities having any Claims of any kind whatsoever in respect of the Purchased Assets, save and except

for persons entitled to the benefit of the Permitted Encumbrances, shall stand absolutely and forever barred, estopped and foreclosed from and permanently enjoined from pursuing, asserting or claiming any and all right, title, estate, interest, royalty, rental, equity of redemption or other Claim whatsoever in respect of or to the Purchased Assets, and to the extent that any such persons or entities remain in the possession or control of any of the Purchased Assets, or any artifacts, certificates, instruments or other indicia of title representing or evidencing any right, title, estate, or interest in and to the Purchased Assets, they shall forthwith deliver possession thereof to the Purchaser (or its nominee).

- 13. The Purchaser (or its nominee) shall be entitled to enter into and upon, hold and enjoy the Purchased Assets for its own use and benefit without any interference of or by the Debtor, or any person claiming by, through or against the Debtor.
- Immediately upon closing of the Transaction, holders of Permitted Encumbrances shall have no claim whatsoever against the Receiver.
- 15. The Receiver is directed to file with the Court a copy of the Receiver's Closing Certificate forthwith after delivery thereof to the Purchaser (or its nominee).
- 16. Pursuant to clause 7(3)(c) of the Personal Information Protection and Electronic Documents Act (Canada) and section 20(e) of the Alberta Personal Information Protection Act, the Receiver is authorized and permitted to disclose and transfer to the Purchaser (or its nominee) all human resources and payroll information in the Debtor's records pertaining to the Debtor's past and current employees. The Purchaser (or its nominee) shall maintain and protect the privacy of such information and shall be entitled to use the personal information provided to it in a manner which is in all material respects identical to the prior use (of such information) to which the Debtor was entitled.
