



Step #	Process	Description/Notes
1	Determine pounds by commodity	Downloaded from Mapper using "Advance Analysis by Commodity" in grower accounting module. Note that Grapes are in packs, not lbs, however this is not a concern as grapes will be removed.
2	Balance pounds to Board Reports	Compare Mapper output to board reports
3	Determine pounds by Grower #	Downloaded from Mapper using "Advance Analysis by Grower Number" in grower accounting module. Note that: 1) this was done in two steps as the download will only do 4 years at a time. 2) this download includes grape packs that will need to be removed and does not include lbs of Ambrosia Export in 2021 crop.
4	Assemble all years into one listing	Combined the 2024-2021 & 2020-2017 downloads and removed 2017 crop year. Note that this download includes grape packs that will need to be removed and does not include pounds of Ambrosia Export in 2021 crop.
5	Determine 2021 Ambrosia Export pounds for individual growers	Using 2021 Ambrosia export crop data, the total Ambrosia pounds was determined to be 2,352,961
6	Determine grape packs for individual growers	Downloaded from Mapper using "Advance Analysis by Commodity" in grower accounting module. Isolate Grapes by Grower Number. Note that Grapes are in packs, not pounds, however this is not a concern as grapes will be removed from calculation.
7	Retrieve Members information	Membership information added from membership registry. Removed grape only growers
8	Identify years to be removed	Non-member growers are removed and volumes in years that growers were not members are removed.
9	Identify Crop Share Members and Growers	The lbs for Crop Share Members was determined using the pounds for the grower lots associated to the crop share accounts and the percentage of the crop sharing arrangement.
10	Calculate the adjustment to pounds that is required for each member	Working spreadsheet to show the adjustments that are required for each grower for grapes, 2021 ambrosia and/or crop share
11	Determine member only pounds	Final listing generated
