To whom it may concern:

Re: Alderbridge Way Limited Partnership, Alderbridge Way GP Ltd. and 0989705 B.C. Ltd. (collectively, "Alderbridge")

On April 1, 2022, Alderbridge was granted an order (the "Initial Order") by the Supreme Court of British Columbia (the "Court") under the Companies' Creditors Arrangement Act, R.S.C. 1985, c. C-36, as amended (the "CCAA"). Alvarez & Marsal Canada Inc. was appointed pursuant to the CCAA as monitor (the "Monitor") of the business and financial affairs of Alderbridge.

The Initial Order provides for, among other things, a stay of proceedings initially expiring on April 11, 2022 (the **"Stay Period"**). The Stay Period may be extended by the Court from time to time.

Alderbridge is continuing to operate in the ordinary course in accordance with the provisions of the Initial Order.

Pursuant to the Initial Order, all persons having oral or written agreements with Alderbridge or statutory or regulatory mandates for the supply of goods and/or services are restrained until further Order of the Court from discontinuing, altering, interfering with or terminating the supply of such goods or services as may be required by Alderbridge, provided that the normal prices or charges for all such goods or services received after the date of the Initial Order are paid by Alderbridge in accordance with normal payment practices of Alderbridge or such other practices as may be agreed upon by the supplier or service provider and each of Alderbridge and the Monitor, or as may be ordered by the Court. Pursuant to the Initial Order, you are not required to extend further credit.

During the Stay Period, parties are prohibited from commencing or continuing any legal proceeding or enforcement action against Alderbridge and all rights and remedies of any party against or in respect of Alderbridge or their assets are stayed and suspended except in accordance with the Initial Order, or with the written consent of Alderbridge and the Monitor, or with leave of the Court.

To date, no claims procedure has been approved by the Court and creditors are therefore not required to file a proof of claim at this time.
