ORDER

THIS MOTION, made by Paul DeBattista, for various relief relating to lands and premises municipally known as 7686 Appleby Line, Milton, Ontario and legally described in Schedule A hereto (the "Milton Property") and to discharge Alvarez & Marsal Canada Inc. ("A&M") as Court-appointed receiver (in such capacity, the "Receiver") of the Milton Property, and other relief ancillary thereto, was heard this day via videoconference.

ON READING the Affidavit of Paul DeBattista sworn March 21, 2024, the First Report of the Receiver dated February 21, 2024 (the "First Report"), the Receiver's Supplement to the First Report dated March 24, 2024 (the "Supplement") and on hearing the submissions of

counsel for Paul DeBattista, counsel for the Receiver and counsel for C & K Mortgage Services Inc.,

- 1. THIS COURT ORDERS that the activities of the Receiver, as set out in the First Report and the Supplement, are hereby approved, provided, however, that only the Receiver, in its personal capacity and only with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approval.
- 2. THIS COURT ORDERS that the fees and disbursements of the Receiver and its counsel, as set out in the First Report, are hereby approved.
- 3. THIS COURT ORDERS that, upon the receipt by the Receiver or its counsel, in trust, of certified funds or a wire transfer in the amount of \$3.35 million, all registrations on title to the Milton Property in favour of the following parties shall be expunged and discharged:
 - (a) C & K Mortgage Services Inc.;
 - (b) 9929916 Canada Inc.; and
 - (c) Laurent Carrier.
- 4. THIS COURT ORDERS that upon the registration in the Land Registry Office for the Land Titles Division of Halton (No. 20) of an Application to Amend the Register Based on Court Order in the form prescribed by the Land Titles Act, the Land Registrar is hereby directed to delete and expunge from title to the Milton Property all of the instruments listed in Schedule B hereto.

- 5. THIS COURT ORDERS that upon the instruments listed in Schedule B hereto being deleted and expunged the Receiver shall be authorized and directed to make the Distributions (as defined in the First Report).
- 6. THIS COURT ORDERS that, upon the Receiver filing a certificate confirming that the Distributions have been completed and all other activities required for the administration of the receivership estate have been completed, the Receiver shall be discharged as Receiver of the undertaking, property and assets of the Milton Property, provided however that notwithstanding its discharge herein: (a) the Receiver shall remain Receiver for the performance of such incidental duties as may be required to complete the administration of the receivership herein, and (b) the Receiver shall continue to have the benefit of the provisions of all Orders made in this proceeding, including all approvals, protections and stays of proceedings in favour of A&M in its capacity as Receiver.
