The Monitor seeks an Order, among other things:

(a) approving reports of the Monitor and the activities and conduct of the Monitor up to and including the date hereof in relation to the Applicants and the CCAA Proceedings (including as described in the Monitor Reports);

(b) approving the fees and disbursements of the Monitor and its counsel for the periods identified in the proposed order, as well as the estimated amounts to be incurred by the Monitor and its counsel in connection with the Monitor's completion of its remaining duties in these CCAA Proceedings;

(c) terminating these CCAA Proceedings effective as at the CCAA Termination Time (as defined in the motion materials);

(d) releasing the Administration Charge granted in the CCAA Proceedings effective as at the CCAA Termination Time;

(e) providing for the discharge of Alvarez & Marsal Canada Inc. as Monitor effective as at the CCAA Termination Time;

(f) releasing and discharging the Monitor and its affiliates, officers, directors, employees, legal counsel and agents from the Release Claims (as defined in the motion materials) effective at the CCAA Termination Time; and

(g) extending the Stay Period to the earlier of (i) the CCAA Termination Time, and (ii) such other date as the Court may order.

I have reviewed the motion materials and heard submissions from counsel for the Monitor. I am satisfied that the requested Order should be made. There is no opposition.
