#### **ENDORSEMENT**

- [1] On November 14, 2023, the Applicants sought and obtained relief under the CCAA pursuant to an Initial Order. <sup>1</sup>
- [2] At this comeback hearing, the Applicants seek approval of (a) the Amended and Restated Initial Order ("ARIO"), among other things, (i) extending the Stay Period; (ii) increasing the amounts which may be borrowed by the Applicants under the DIP Agreement; and (iii) approving the Piper Engagement Letter and the Transaction Fee Charge; (b) the Transaction to be implemented pursuant to the proposed Approval, Vesting, and Distribution Order; and (c) an Assignment Order assigning the Sellers' contracts to the Purchaser or its designee in connection with the Transaction.
- [3] No one appeared today to oppose the relief sought.
- [4] The facts underlying this motion are summarized in the Applicants' factum at paragraphs 7-29.

- [5] I have reviewed the motion materials including the affidavit evidence and the First Report of the Monitor. I heard submissions from counsel for the Applicants, counsel for the Monitor, and counsel for the Lenders.
- [6] I am satisfied that the requested ARIO should be made. In this respect, I accept the Applicants' submissions at paragraphs 33-52 of their factum.
- [7] I am satisfied that the Asset Purchase Agreement and the Transaction should be approved and that Confidential Appendices "1" and "2" should be sealed as provided for in the requested Order. I am satisfied that the requested distributions should be granted. I am satisfied that the requested Approval, Vesting and Distribution Order should be made. In this respect, I accept the Applicants' submissions at paragraphs 53-85 of their factum.
- [8] I am satisfied that the requested Assignment Order should be made. In this respect, I accept the Applicants' submissions at paragraphs 86-90 of their factum.
- [9] Orders to issue in forms of Orders signed by me today.
