ORDER

THIS MOTION, made by the Applicants pursuant to the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended, for an order extending the stay of proceedings to DAK Capital Inc. ("DAK"), and sealing Confidential Exhibit "I" to the Affidavit of A. Williams sworn September 26, 2024 (the "Confidential Exhibit") and pages 25 to 32 from Transcript of the Cross-Examination of D. Paterson, October 3, 2024 (the "Confidential Transcript"), was heard this day in-person.

ON READING the Motion Record of the Applicants, the Responding Motion Record of Canopy Growth Corporation ("Canopy"), the Supplementary and Reply Motion Record of the Applicants, the Transcript Brief of Canopy, the Factum of the Applicants, the Responding Factum of Canopy, the Reply Factum of the Applicants, the Brief of Authorities of the Applicants, the Responding Book of Authorities of Canopy, and the Supplement to the Second Report of Alvarez & Marsal Canada Inc., in its capacity as monitor (the "Monitor") of the Applicants, dated October 16, 2024,

ON HEARING the submissions of counsel for the Applicants, Canopy, and the Monitor, and such other counsel as were in attendance,

- 1. **THIS COURT ORDERS** that any and all proceedings or enforcement processes in any court or tribunal against or in respect of DAK, and that involve or relate to the Applicants (the "**DAK Proceedings**"), shall be stayed up to and including the date on which the Monitor issues a certificate certifying that a transaction has been completed pursuant to the sale and investment solicitation process described in the Order of Justice Cavanagh dated September 18, 2024 or until further Order of the Court, except with the written consent of DAK and the Monitor (the "**DAK Stay**"). For greater certainty, the DAK Proceedings include the arbitration proceeding commenced on March 8, 2024, by Canopy Growth, Tweed, and Tweed Leasing Corporation against Ontario Inc., 2161907 Alberta Ltd., 2733181 Ontario Inc., 14284585 Canada Inc., and DAK.
- 2. **THIS COURT ORDERS** that notwithstanding Paragraph 1 of this Order, the DAK Stay shall not apply to any proceeding that the Bank of Montreal ("**BMO**") may commence or continue against DAK in relation to any loan or credit facility that BMO has advanced to DAK.
- 3. **THIS COURT ORDERS** that the Confidential Exhibit and the Confidential Transcript shall be sealed until further order of this Court.
