**UPON THE APPLICATION** (the "**Application**") of Sugarbud Craft Growers Corp., Trichome Holdings Corp. and 1800905 Alberta Ltd. (collectively the "**Debtor Companies**"), for an Order sealing certain confidential information, among other things; **AND UPON HAVING READ** the Originating Application, the Application for Amended and Restated Initial Order, the Affidavit of Daniel T. Wilson, sworn on October 7, 2022 (the "**CCAA Wilson Affidavit**"); and the Affidavit of Service of Joy Mutuku, filed; **AND UPON** reading the consent of Alvarez & Marsal Canada Inc. to act as the Monitor (the "**Monitor**"); **AND UPON IT** appearing that all interested and affected parties have been served with notice of the Application; **AND UPON HEARING** the submissions

of counsel for the Debtor Companies, the Monitor and all other interested parties present;

**IT IS HEREBY ORDERED AND DECLARED THAT:**

1. Part 6, Division 4 of the *Alberta Rules of Court* does not apply to the Application and the Clerk of the Court is hereby directed to seal Confidential Exhibit "A" (the "**Confidential Exhibit**") to the CCAA Wilson Affidavit.
2. The clerk of the Court is hereby directed to seal the Confidential Exhibit on the Court file until the earlier of:
  - i) October 18, 2023;
  - ii) an Order of this Court directs that the Confidential Exhibit be filed in this Action; or
  - iii) the Monitor files a certificate seeking its discharge as Monitor of the Debtor Companies.
