Upon the Application of Mike Russell, lawyer on behalf of Bank of Montreal ("**BMO**"), and upon hearing from Mike Russell on behalf of BMO, and counsel present on behalf of any other interested parties; and upon reading the petition of BMO, the Applicant Creditor, including the Affidavit of Sandy Hayer, filed; and it appearing to the Court that the following acts of bankruptcy have been committed by the Respondents, Morris Industries Ltd., Morris Sales & Service Ltd., 101098672 Saskatchewan Ltd. and Morris Industries (USA) Inc. (collectively, the "**Debtors**"), namely, each of the Debtors has, within the six months preceding the date of the filing of the Application for a Bankruptcy Order, committed the following acts of bankruptcy pursuant to subsections 42(1)(f) and 42(1)(j) of the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3, respectively:

- (a) each of the Debtors has exhibited to its creditors that it is insolvent; and
- (b) each of the Debtors has ceased to meet its liabilities generally as they become due.

The Court orders:

- 1. Each of the Debtors shall be and is hereby adjudged bankrupt and a bankruptcy order is hereby made against each of the Debtors.
- 2. Alvarez & Marsal Canada Inc. shall be and is hereby appointed as Licensed Insolvency Trustee of the estate of each of the Debtors.
- 3. The costs of the Applicant Creditor shall be paid out of the estates of the bankrupt Debtors, subject to the right of taxation thereof.
- 4. Service of this Order upon each of the Debtors by delivery to Alvarez & Marsal Canada Inc., in its capacity as Monitor in the proceedings under the *Companies' Creditors Arrangement Act* in Q.B. 1884 of 2019, shall be good, valid and sufficient.

5. The Bankruptcy Application herein in regard to Contour Realty Inc. shall be and is hereby adjourned, *sine die*, to be brought back before The Honourable Mr. Justice R.S. Smith on seven days' notice.
