All activities, actions, conduct and proposed courses of action of the Monitor (collectively, the "Actions of the Monitor") from August 14, 2020 to and including September 14, 2020 in relation to the discharge of its duties and mandate as Monitor pursuant to the various Orders of the Court of Queen's Bench for Saskatchewan in these proceedings, as such Actions of the Monitor are more particularly described in the Tenth Report, shall be and are hereby approved and confirmed.
- 3. All of the professional fees and disbursements of the Monitor and its legal counsel, MLT Aikins LLP, from August 1, 2020 to and including August 31, 2020, as more particularly described in the Tenth Report, shall be and are hereby approved and confirmed.

4. The Confidential Appendix to the Tenth Report shall be kept sealed and confidential and shall not form part of the public record, but rather shall be placed, kept separate and apart from all other contents of the Court file, in a sealed envelope which shall bear a notice which sets out the title of these proceedings and a statement that the contents are subject to a sealing order and shall only be opened upon further order of the Court.
