PLEASE TAKE NOTICE that on February 17, 2020, the Chapter 11 Debtors each filed voluntary petitions for relief under Chapter 11 of the U.S. Bankruptcy Code with the United States Bankruptcy Court for the Eastern District of Virginia (the "U.S. Court" and the proceedings commenced thereby, the "Chapter 11 Proceedings"). In connection with the Chapter 11 Proceedings, Pier 1 Imports, Inc. has been appointed as the foreign representative of the estates of the Chapter 11 Debtors (the "Foreign Representative"). The Foreign Representative's address is 100 Pier 1 Place, Fort Worth, TX 76102. The Chapter 11 Debtors do not maintain a separate Canadian legal entity for their Canadian operations. Pier 1 Imports (U.S.), Inc. holds the leases for, operates all of the Chapter 11 Debtors' retail stores, and employs all the Chapter 11 Debtors' employees in Canada.
