- 1. The term of the Amended and Restated Initial Order granted by the Honourable Mr. Justice R.S. Smith in these proceedings on January 16, 2020 (the "ARI Order"), and the stay of proceedings provided for therein, insofar as they pertain to Contour Realty Inc., shall be and are hereby extended from 11:59 p.m. on Wednesday, March 31, 2021 to 11:59 p.m. on Friday, July 30, 2021.
- 2. From and after the date of this Order, the Administration Charge and the Directors' Charge (as those terms are defined in the ARI Order):
  - (a) shall attach solely to the real property owned by Contour Realty Inc. more particularly described in Schedule "A" hereto (the "Contour Real Property"); and
  - (b) shall be terminated, discharged and vacated as against all other assets of Contour Realty Inc., save and except for the Contour Real Property.
