## 1.0 INTRODUCTION

- 1.1 On January 25, 2021 (the “**Filing Date**”), Yatsen Group of Companies Inc. (“**YGC**”), SAR Real Estate Inc. (“**SAR Real Estate**”) and the 35 companies listed in **Appendix “A”** (collectively, the “**Applicants**”<sup>1</sup>) obtained an initial order (the “**Initial Order**”) under the *Companies’ Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended (the “**CCAA**”). The proceedings are referred to herein as the “**CCAA Proceedings**”.
- 1.2 Alvarez & Marsal Canada Inc. (“**A&M**”), in its capacity as Proposed Monitor, filed the Pre-Filing Report of the Proposed Monitor (the “**Pre-Filing Report**”) prior to the commencement of the CCAA Proceedings. The Monitor has also filed the First Report of the Monitor dated January 29, 2021 (the “**First Report**”) and the Second Report of the Monitor dated March 22, 2021 (the “**Second Report**”). These reports and other Court-filed documents in the CCAA Proceedings are available on the Monitor’s case website at [www.alvarezandmarsal.com/YatsenGroup](http://www.alvarezandmarsal.com/YatsenGroup) (the “**Case Website**”). A copy of the Second Report is attached hereto as **Appendix “B”**.
- 1.3 The Initial Order, among other things:
- (i) appointed A&M as monitor of the Applicants (in such capacity, the “**Monitor**”);
  - (ii) granted a stay of proceedings against the Applicants up to and including February 3, 2021 (the “**Stay Period**”);

- (iii) granted the DIP Lenders' Charge up to a maximum of \$500,000; and
- (iv) authorized and empowered the Monitor to act as the foreign representative of the Applicants and to apply for foreign recognition of these proceedings in the United States pursuant to Chapter 15 of the United States Bankruptcy Code (the "**Chapter 15 Case**")<sup>2</sup>.

1.4 On February 2, 2021, the Court granted the Amended and Restated Initial Order which modified the Initial Order in certain respects, including, among other things, extending the Stay Period to March 31, 2021 and increasing the DIP Lenders' Charge up to a maximum of \$5 million. As described in section 5.0 of the Second Report, on February 24, 2021, the United States Bankruptcy Court for the District of Delaware (the "**US Court**") entered an order (the "**Chapter 15 Recognition Order**") enforcing the Initial Order, including any extensions, amendments or modifications thereto, in the United States on a final basis, recognizing the CCAA Proceedings as a foreign main proceeding.

1.5 On March 29, 2021, among other things, the Court granted: (i) the Stay Extension Order further extending the Stay Period to June 30, 2021; and (ii) the Settlement Approval Order approving the Yorktown Settlement Agreement (defined and described below).

1.6 Each of the Applicants are directly or indirectly owned by Yatsen Group Inc. ("**YGI**"), a wholly owned subsidiary of Edjar International Inc. ("**EII**" and together with its direct and indirect subsidiaries, the "**Company**"). At the commencement of the CCAA proceedings, the Company operated approximately 226 Japanese quick service restaurants across the

United States, of which 189 are leased directly by Applicants. YGI's head offices are located in Markham, Ontario.

- 1.7 The CCAA Proceedings were commenced by the Applicants to stabilize their business and to allow them to pursue a restructuring plan that includes: (i) continuing discussions with landlords in an effort to obtain sustainable lease amendments; and (ii) the termination of leases in respect of unsustainable locations and those locations where the Applicants cannot reach satisfactory consensual go-forward arrangements with landlords.
- 1.8 The purpose of this report (the “**Third Report**”) is to provide the Court with information, and where applicable, the Monitor's views on:
- (i) updates regarding the CCAA Proceedings and the Chapter 15 Case since the date of the Second Report (March 22, 2021);
  - (ii) the Applicants' motion for an order (the “**Stay Extension Order**”), which among other things seeks an extension of the Stay Period to July 30, 2021;
  - (iii) the Yorktown Settlement Agreement;
  - (iv) the cash flow results of the Applicants for the 12-week period ended June 13, 2021;
  - (v) the Applicants' updated cash flow forecast for the 13-week period ending September 12, 2021;
  - (vi) activities of the Monitor since the date of the Second Report; and
  - (vii) the Monitor's conclusions and recommendations in connection with the foregoing.

## 2.0 TERMS OF REFERENCE AND DISCLAIMER

2.1 In preparing this Third Report, A&M, in its capacity as Monitor, has been provided with, and has relied upon, unaudited financial information, books and records and financial information prepared by the Company and has held discussions with the Company's management and its legal and financial advisors (collectively, the "**Information**"). Except as otherwise described in this Third Report:

- (i) the Monitor has reviewed the Information for reasonableness, internal consistency and use in the context in which it was provided. However, the Monitor has not audited or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would wholly or partially comply with Canadian Auditing Standards ("**CASs**") pursuant to the *Chartered Professional Accountants Canada Handbook* (the "**CPA Handbook**") and, accordingly, the Monitor expresses no opinion or other form of assurance contemplated under CASs in respect of the Information; and
- (ii) some of the information referred to in this Third Report consists of forecasts and projections. An examination or review of the financial forecasts and projections, as outlined in the CPA Handbook, has not been performed.

2.2 Future oriented financial information referred to in this Third Report was prepared based on the Company's estimates and assumptions. Readers are cautioned that since projections are based upon assumptions about future events and conditions that are not ascertainable, actual results will vary from the projections, even if the assumptions materialize, and the variations could be significant.

- 2.3 This Third Report should be read in conjunction with the affidavit of Joseph McCullagh sworn on June 17, 2021 (the “**Fourth McCullagh Affidavit**”) for additional background and other information regarding the Applicants. Capitalized terms used and not defined in this Third Report have the meanings given to them in the Pre-Filing Report, First Report, Second Report (collectively, the “**Prior Reports**”) or the Fourth McCullagh Affidavit, as applicable.
- 2.4 Unless otherwise stated, all monetary amounts contained herein are expressed in Canadian dollars (“**CAD**”).

### **3.0 UPDATE SINCE THE DATE OF THE SECOND REPORT**

#### Lease Disclaimer Notices

- 3.1 On May 6, 2021, the Applicants, with approval from the Monitor, issued notices of disclaimer in respect of three leases and subsequently vacated the respective locations within the 30-day notice period.
- 3.2 As described in the Prior Reports, the Applicants have also previously issued notices of disclaimer in respect of 27 leases and three related storage rental agreements. Of the 27 locations previously disclaimed, the Monitor understands that the Applicants have vacated 22 of the locations. With respect to the remaining five locations, the Monitor understands that the Applicants reached consensual arrangements with each applicable landlord to remain in such locations past the 30-day notice period, subject to the payment of the applicable rent during such extended period.
- 3.3 The Applicants have also vacated 6 locations where the leases have expired.

### Rent Payments

- 3.4 As described in the Pre-Filing Report, consistent with past practice, rent obligations of the Applicants are being paid directly to landlords on their behalf by applicable Individual Opcos and franchisees (as described further in the Pre-Filing Report).
- 3.5 The Monitor has confirmed with the Applicants that rent relating to the period after the Filing Date, including most recently June rents, continues to be paid by Individual Opcos on behalf of the Applicants for ongoing leases, including the five disclaimed locations that have not yet been vacated, as described above.
- 3.6 As described in the Pre-Filing Report, to provide additional comfort to landlords that rents will be paid during the CCAA Proceedings the US\$3.1 million Rent Reserve, representing approximately one month's aggregate rent obligation of the Applicants, was funded and continues to be held in escrow by the Monitor for the benefit of landlords. No draws on the Rent Reserve have been necessary.

### Continuing Landlord Discussions

- 3.7 The Applicants, with the assistance of their advisors, continue to advance negotiations with landlords in an effort to reach satisfactory consensual lease amendments and to address the sizeable lease arrears outstanding. As of the date of this Third Report, the Applicants have made significant progress in this regard such that a number of lease amendments have been executed or negotiations have sufficiently advanced such that executable agreements are anticipated in the near term. Given the sensitive stage of the ongoing discussions with landlords, coupled with the commercial sensitivities associated with agreements executed

to date, further details in this regard are not included in this Third Report; however, the Monitor is satisfied with the Applicants' ongoing progress with landlords and intends to provide additional reporting with respect to same at the appropriate time.

- 3.8 As further described in the Fourth Affidavit, as the Applicants continue discussions with remaining landlords, they are seeking a 30-day extension of the Stay Period to July 30, 2021 to attempt to complete negotiations and execute satisfactory lease amendments with the majority of the their landlords.

#### **4.0 YORKTOWN SETTLEMENT AGREEMENT**

- 4.1 As described in the Second Report, one of the original Applicants, SJ Yorktown Foods Inc. ("**SJ Yorktown**"), and its landlord, entered into a settlement agreement (the "**Yorktown Settlement Agreement**") addressing outstanding rent arrears and providing for certain go-forward lease amendments acceptable to both parties.
- 4.2 The Yorktown Settlement Agreement was approved by the Court pursuant to the Settlement Approval Order dated March 29, 2021 and became effective on April 23, 2021 following the delivery of the Monitor's Certificate in accordance with the Settlement Approval Order. Accordingly, following April 23, 2021: (i) SJ Yorktown ceased being an Applicant in the CCAA Proceedings and was released from the Charges pursuant to the Settlement Approval Order; and (ii) the Monitor was discharged from its duties, responsibilities, liabilities and obligations as Monitor of SJ Yorktown.
- 4.3 A hearing before the US Court has been scheduled for July 28, 2021 to seek entry of an order terminating the Chapter 15 Proceedings in respect of SJ Yorktown.

## 5.0 CASH FLOW RESULTS RELATIVE TO FORECAST

5.1 Actual receipts and disbursements for the period from March 21 to June 13, 2021 (the “**Reporting Period**”), as compared to the cash flow forecast attached as Appendix “C” to the Second Report, are summarized in the following table:

5.2 During the Reporting Period, the Applicants incurred a positive net cash flow variance of approximately \$1.2 million relative to forecast as professional fees were significantly lower than projected. At this time, it is expected that most of this variance will be permanent.

5.3 As at June 13, 2021, the Applicants’ borrowings under the DIP Facility, including accrued interest, were approximately \$1.5 million. The maturity date of the DIP Facility has been extended from July 31, 2021 to September 30, 2021, pursuant to an amending agreement with the DIP Lender.

## 6.0 UPDATED AND EXTENDED CASH FLOW FORECAST

6.1 The Applicants have prepared an updated and extended cash flow forecast (the “**Updated Forecast**”) for the 13-week period from June 14 to September 12, 2021 (the “**Cash Flow Period**”). A copy of the Updated Forecast, together with a summary of assumptions is

attached hereto as **Appendix “C”**. A summary of the Updated Forecast is provided in the following table:

6.2 The Monitor notes the following with respect to the Updated Forecast:

- (i) as at the date of this Third Report, the Applicants have a negligible cash balance, which will not change during the course of the CCAA Proceedings as funds will be drawn on an “as-needed” basis from the DIP Facility to pay professional fees as the proceedings advance;
- (ii) other than professional fees, the Applicants do not have any other cash flow activity forecast during the Cash Flow Period; and
- (iii) as described in the Prior Reports, consistent with past practice, all rent obligations owing by the Applicants during the CCAA Proceedings are to be paid directly by the Individual Opcos and franchisees pursuant to the occupancy agreements or subleases.

## **7.0 EXTENSION OF THE STAY PERIOD**

7.1 Pursuant to the Stay Extension Order, the current Stay Period expires on June 30, 2021. The Applicants are seeking a 30-day extension of the Stay Period to and including July 30, 2021.

7.2 The Monitor supports the requested extension to the Stay Period for the following reasons:

- (i) as described above, the Monitor understands that the Applicants are in advanced stages of negotiations with landlords representing a significant number of their leases, and the extension will provide the Applicants with the necessary time to execute additional lease amendments, or alternatively issue lease disclaimer notices, with a view to finalizing a restructuring plan in the near term;
- (ii) the Applicants have sufficient liquidity through the requested extended Stay Period; and
- (iii) the Applicants continue to act in good faith and with due diligence in their efforts to advance the CCAA Proceedings.

## **8.0 MONITOR'S ACTIVITIES SINCE THE DATE OF THE SECOND REPORT**

8.1 In addition to those activities described above, the activities of the Monitor from the date of the Second Report have also included the following:

- (i) participating in regular discussions with the Company and its legal counsel and advisors regarding the CCAA Proceedings, including in connection with ongoing discussions and negotiations with landlords;

- (ii) together with its legal counsel, reviewing and commenting on various of the Applicants' lease amendment agreements;
- (iii) together with its legal counsel, working with the Applicants to develop a structure for a claims procedure, creditor meeting and plan of arrangement, each of which the Applicants are continuing to advance as of the date hereof;
- (iv) participating in weekly update calls with Hilco Real Estate, LLC to discuss progress being made with landlords;
- (v) issuing the Monitor's Certificate in relation to the Yorktown Settlement Agreement;
- (vi) working with the Monitor's US counsel, Young Conaway Stargatt & Taylor, LLP, and other counsel involved in the Chapter 15 Case;
- (vii) continuing to assist the Applicants with communications related to the CCAA Proceedings and Chapter 15 Case, including updating the Case Website with Court-filed documents;
- (viii) monitoring the Applicants' cash flow; and
- (ix) with the assistance of legal counsel, preparing this Third Report.

## **9.0 CONCLUSIONS AND RECOMMENDATIONS**



  - (b) provides for the sealing of the Yorktown Settlement Agreement and of the Confidential Amendments Summary thereof prepared by the Applicants; and
  - (c) removes SJ Yorktown as an Applicant in the CCAA Proceedings and discharges the Monitor with respect to its duties and obligations as Monitor of SJ Yorktown;
- (iv) the cash flow results of the Applicants for the eight-week period ended March 20, 2021;

- (v) the Applicants' updated cash flow forecast for the 15-week period ending July 3, 2021;
- (vi) activities of the Monitor since the date of the First Report; and
- (vii) the Monitor's conclusions and recommendations in connection with the foregoing.

## **2.0 TERMS OF REFERENCE AND DISCLAIMER**

2.1 In preparing this Second Report, A&M, in its capacity as Monitor, has been provided with, and has relied upon, unaudited financial information, books and records and financial information prepared by the Company (including information provided by the Operations Segment's financial advisor, CR3 Partners, LLC) and has held discussions with the Company's management and its legal and financial advisors (collectively, the "**Information**"). Except as otherwise described in this Second Report:

- (i) the Monitor has reviewed the Information for reasonableness, internal consistency and use in the context in which it was provided. However, the Monitor has not audited or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would wholly or partially comply with Canadian Auditing Standards ("**CASs**") pursuant to the *Chartered Professional Accountants Canada Handbook* (the "**CPA Handbook**") and, accordingly, the Monitor expresses no opinion or other form of assurance contemplated under CASs in respect of the Information; and

(ii) some of the information referred to in this Second Report consists of forecasts and projections. An examination or review of the financial forecasts and projections, as outlined in the CPA Handbook, has not been performed.

2.2 Future oriented financial information referred to in this Second Report was prepared based on the Company's estimates and assumptions. Readers are cautioned that since projections are based upon assumptions about future events and conditions that are not ascertainable, actual results will vary from the projections, even if the assumptions materialize, and the variations could be significant.

2.3 This Second Report should be read in conjunction with the affidavit of Joseph McCullagh sworn on March 22, 2021 (the "**Third McCullagh Affidavit**") for additional background and other information regarding the Applicants. Capitalized terms used and not defined in this Second Report have the meanings given to them in the Pre-Filing Report, First Report or the Third McCullagh Affidavit, as applicable.

2.4 Unless otherwise stated, all monetary amounts contained herein are expressed in Canadian dollars ("**CAD**").

### **3.0 UPDATE SINCE THE DATE OF THE FIRST REPORT**

#### Lease Disclaimer Notices

3.1 Following the granting of the Initial Order, the Applicants issued notices of disclaimer (the "**Lease Disclaimer Notices**") in respect of 27 leases. The Applicants also issued notices of disclaimer in respect of three storage rental agreements related to locations subject to Lease Disclaimer Notices.

3.2 Of the 27 locations subject to Lease Disclaimer Notices, the Applicants vacated 21 within the 30-day notice period. With respect to the remaining six locations, the Monitor understands that the Applicants and each of the applicable landlords have reached consensual arrangements to extend the 30-day notice period to allow the parties to continue to discuss potential lease amendments in respect of each landlord's group of leases. If acceptable lease amendments cannot be reached, the Applicants will ultimately vacate applicable locations.

3.3 The Applicants have also vacated five locations where the leases have expired.

#### Rent Payments

3.4 As described in the Pre-Filing Report and the First Report, consistent with past practice, rent obligations of the Applicants are being paid directly to landlords on their behalf by applicable Individual Opcos and franchisees (as defined and described in the Pre-Filing Report).

3.5 The Monitor has confirmed with the Applicants that rent relating to the period after the Filing Date, including most recently March rents, continues to be paid on behalf of the Applicants for ongoing leases (and on consensual modified arrangements for the six locations where the leases were disclaimed but the locations have not yet been vacated, as agreed by the applicable Applicants and landlords).

3.6 As described in the Pre-Filing Report, to provide additional comfort to landlords that rents will be paid during the CCAA Proceedings the US\$3.1 million Rent Reserve, representing approximately one month's aggregate rent obligation of the Applicants, was funded and

continues to be held in escrow by the Monitor for the benefit of landlords. No draws on the Rent Reserve have been necessary.

Continuing Landlord Discussions

3.7 As described in the Third McCullagh Affidavit, the Applicants, with the assistance of Hilco, continue to advance their discussions and negotiations with landlords in an effort to reach satisfactory consensual lease amendments and to address the sizeable lease arrears outstanding.

3.8 The Monitor participates in regular meetings with the Company and Hilco to receive updates on the ongoing discussions with landlords. The Monitor understands that meaningful progress has been made with the majority of landlords and will continue to update the Court as these negotiations advance.

Wells Fargo

3.9 As described in the Pre-Filing Report, YGC (but none of the other Applicants) is a guarantor to the Wells Fargo Credit Facility. Wells Fargo has raised no objection to the CCAA Proceedings or the DIP Facility, though it had reserved its rights in all respects on the understanding that it will be an unaffected creditor in any restructuring that may occur during the CCAA Proceedings. The Amended and Restated Initial Order provides that Wells Fargo will be an unaffected creditor.

3.10 As described in the Third McCullagh Affidavit, on March 8, 2021, Wells Fargo and the Company executed an amendment to the Wells Fargo Credit Facility which, among other

things, waived the past defaults and revised certain financial covenants to take into account the impact of the COVID-19 pandemic and these CCAA Proceedings.

#### **4.0 YORKTOWN SETTLEMENT AGREEMENT**

- 4.1 One of the Applicants in these CCAA Proceedings is SJ Yorktown. The Yorktown Lease is SJ Yorktown's only location, and the landlord at this location is YTC. As at the Filing Date, there was approximately US\$164,383 of outstanding rent arrears owed to YTC. Since the Filing Date, the Company has paid rent to YTC in the ordinary course.
- 4.2 As described in the Third McCullagh Affidavit, in November 2020, SJ Yorktown and YTC reached a verbal agreement in principle that would address the rent arrears and would provide for certain lease amendments acceptable to both parties, subject to documentation and final approval by YTC.
- 4.3 As at the Filing Date, documentation of the verbal agreement and final approval by YTC had not been received by SJ Yorktown and accordingly SJ Yorktown determined it was in its best interests to be included as an Applicant in the CCAA Proceedings. Following the Filing Date, SJ Yorktown and YTC resumed their discussions and ultimately reached and documented the Yorktown Settlement Agreement with lease amendments acceptable to both parties. A copy of the Yorktown Settlement Agreement, together with the Confidential Amendments Summary, are attached to the Third McCullagh Affidavit as confidential exhibits, and an overview of key terms of the Yorktown Settlement Agreement is provided in the Third McCullagh Affidavit.

- 4.4 The Monitor and its legal counsel have reviewed the Yorktown Settlement Agreement. The Monitor supports the Yorktown Settlement Agreement as: (i) the terms are commercially reasonable and allow for the leased location to remain open and continue to operate in the normal course; (ii) the settlement involves only one lease and one Applicant; and (iii) the Monitor does not believe other creditors of the Applicants are materially prejudiced by the Yorktown Settlement Agreement.

Sealing Order

- 4.5 As described in the Third McCullagh Affidavit, the Applicants are seeking an order that the Yorktown Settlement Agreement and the Confidential Amendments Summary both be sealed from the public record to keep the agreement and its contents confidential in order to not prejudice their ongoing discussions with the Applicants' other landlords. The Yorktown Settlement Agreement provides that the parties thereto shall keep the contents of such agreement confidential.
- 4.6 The Monitor supports the request to seal the Confidential Exhibits on the basis that the information therein is specific to the Yorktown location and should not be on the public record so as to potentially be used by other landlords in their ongoing negotiations with the Applicants. The Monitor believes that the potential harm to the Applicants and their restructuring efforts from the disclosure of the Confidential Exhibits significantly outweighs any potential benefits of such disclosure.

Removal of SJ Yorktown as an Applicant

- 4.7 Following the implementation of the Yorktown Settlement Agreement, if approved by the Court, all of the outstanding issues and defaults in respect of SJ Yorktown's lease obligations will have been consensually resolved, and there will be no further need for SJ Yorktown to continue as an Applicant in the CCAA Proceedings. As such, following the effective date of the Yorktown Settlement Agreement, the Applicants are requesting: (i) that SJ Yorktown be removed as an Applicant in the CCAA Proceedings; and (ii) the Monitor be discharged with respect to its duties, responsibilities, liabilities and obligations as Monitor of SJ Yorktown.

**5.0 CHAPTER 15 CASE**

- 5.1 Pursuant to the Initial Order, on January 25, 2021, the Monitor, as the foreign representative of the Applicants, filed petitions for recognition of the CCAA Proceedings under Chapter 15 in the United States Bankruptcy Court for the District of Delaware (the "**US Court**"). A hearing on the first day motions was held on January 27, 2021 before the Honorable Brendan Linehan Shannon.
- 5.2 At the first day hearing, among other things, the US Court granted an Order Granting Provisional Relief (the "**Chapter 15 Provisional Order**") recognizing and enforcing the Initial Order in the United States on an interim basis.
- 5.3 On February 24, 2021, the US Court entered the Chapter 15 Recognition Order, enforcing the Initial Order in the United States on a final basis, recognizing the CCAA Proceedings as a foreign main proceeding pursuant to section 1517 of title 11 of the United States Code,

providing a stay of any execution against the assets of the Applicants located in the United States, and authorizing the Applicants to perform their obligations under the DIP Facility. A copy of the Chapter 15 Recognition Order is attached to the Third McCullagh Affidavit as Exhibit “D”.

5.4 All documents filed in the Chapter 15 Case are available at <https://cases.primeclerk.com/yatsen/>.

## 6.0 CASH FLOW RESULTS RELATIVE TO FORECAST

6.1 Actual receipts and disbursements for the period from January 25 to March 20, 2021 (the “**Reporting Period**”), as compared to the cash flow forecast attached as Appendix “C” to the Pre-Filing Report, are summarized in the following table:

6.2 During the Reporting Period, the Applicants incurred a positive net cash flow variance of approximately \$600,000 relative to forecast as professional fees were lower than forecast. At this time, it is too early in the CCAA Proceedings to conclude whether this positive variance will be permanent.

- 6.3 As at March 20, 2021, the Applicants' borrowings under the DIP Facility, including accrued interest, were approximately \$1.0 million.

## 7.0 UPDATED AND EXTENDED CASH FLOW FORECAST

- 7.1 The Applicants have prepared an updated and extended cash flow forecast (the "**Updated Forecast**") for the 15-week period from March 21 to July 3, 2021 (the "**Cash Flow Period**"). A copy of the Updated Forecast, together with a summary of assumptions is attached hereto as **Appendix "C"**. A summary of the Updated Forecast is provided in the following table:

- 7.2 The Monitor notes the following with respect to the Updated Forecast:

- (i) as at the date of this Second Report, the Applicants have a negligible cash balance, which will not change during the course of the CCAA Proceedings as funds will be drawn on an “as-needed” basis from the DIP Facility to pay professional fees as the proceedings advance;
- (ii) other than professional fees, the Applicants’ do not have any other cash flow activity forecast during the Cash Flow Period; and
- (iii) as described in the Pre-Filing Report, consistent with past practice, all rent obligations owing by the Applicants during the CCAA Proceedings will be paid directly by the Individual Opcos and franchisees pursuant to the occupancy agreements or subleases.

## **8.0 EXTENSION OF THE STAY PERIOD**

8.1 Pursuant to the Amended and Restated Initial Order, the current Stay Period expires on March 31, 2021. The Applicants are seeking an extension of the Stay Period to and including June 30, 2021.

8.2 The Monitor supports the requested extension to the Stay Period for the following reasons:

- (i) the extension is necessary to enable the Applicants to continue ongoing discussions and negotiations with landlords to attempt to achieve satisfactory consensual lease amendments in order to make applicable restaurant locations viable;
- (ii) the Applicants have sufficient liquidity through the requested extended Stay Period; and

- (iii) the Applicants continue to act in good faith and with due diligence in their efforts to advance the CCAA Proceedings.

## **9.0 MONITOR'S ACTIVITIES SINCE THE DATE OF THE FIRST REPORT**

9.1 In addition to those activities described above, the activities of the Monitor from the date of the First Report have also included the following:

- (i) participating in regular discussions with the Company and its legal counsel and advisors regarding the CCAA Proceedings, including in connection with ongoing discussions and negotiations with landlords;
- (ii) assessing the Yorktown Settlement Agreement with its legal counsel to ensure the terms thereof are commercially reasonable and should not materially prejudice other creditors of the Applicants.
- (iii) working with the Monitor's US counsel, Young Conaway Stargatt & Taylor, LLP, and other counsel involved in the Chapter 15 Case to obtain recognition by the US Court of orders granted by this Court;
- (iv) continuing to assist the Applicants with communications related to the CCAA Proceedings and Chapter 15 Case, including updating the Case Website with Court-filed documents and coordinating with Prime Clerk regarding the US case docket and noticing requirements;
- (v) monitoring the Applicants' cash flow; and
- (vi) with the assistance of legal counsel, preparing this Second Report.

## **10.0 CONCLUSIONS AND RECOMMENDATIONS**

- 10.1 For the reasons set out in this Second Report, the Monitor respectfully recommends that the Court grant the Stay Extension Order and the Settlement Approval Order containing the relief requested by the Applicants.

(“**SAR Real Estate**”) and the 36 companies listed in **Appendix “A”** (collectively, the “**Applicants**”<sup>1</sup>) obtained an initial order (the “**Initial Order**”) under the *Companies’ Creditors Arrangement Act*, R.S.C. 1985, c. - 1.2 Alvarez & Marsal Canada Inc. (“**A&M**”), in its capacity as Proposed Monitor, filed the Pre-Filing Report of the Proposed Monitor (the “**Pre-Filing Report**”) prior to the commencement of the CCAA Proceedings. Capitalized terms used and not defined in this First Report have the meanings given to them in the Pre-Filing Report or the Second McCullagh Affidavit, as applicable.

- 2.4 Unless otherwise stated, all monetary amounts contained herein are expressed in Canadian dollars.

### **3.0 UPDATE SINCE THE INITIAL ORDER**

#### Landlord Communications

- 3.1 The Company has confirmed to the Monitor that, following the granting of the Initial Order, each of the Applicants' landlords were advised of the CCAA Proceedings by either the Company or Hilco.

#### Notices to Disclaim Certain Leases

- 3.2 Following the granting of the Initial Order, on January 25, 2021, with the approval of the Monitor, the Applicants issued notices of disclaimer (the "**Lease Disclaimer Notices**") in respect of 27 leases. In three instances, the Applicants, with the approval of the Monitor, also issued notices of disclaimer in respect of storage rental agreements that relate to locations subject to a Lease Disclaimer Notice.
- 3.3 As described further below, the Monitor has confirmed with the Applicants that rent has been paid, on behalf of the Applicants, to the applicable landlords for the 30-day disclaimer notice period.

### Rent Payments

- 3.4 As described in the Pre-Filing Report, because the Applicants have a negligible cash position and do not otherwise generate cash flow, the lease obligations of the Applicants (189 leases as at the Filing Date) were previously satisfied by various Individual Opcos and franchisees pursuant to occupancy and/or sublease agreements for each restaurant location. However, following the onset of the COVID-19 pandemic and the resulting restaurant closures and related financial difficulties, the Individual Opcos and franchisees generally stopped making their applicable rent payments, as set forth in greater detail in the First McCullagh Affidavit.
- 3.5 Prior to the restaurant closures, the Individual Opcos and franchisees historically paid rent directly to the applicable landlord on behalf of the Applicants. The Monitor understands that during the CCAA Proceedings this practice will continue.
- 3.6 As described in the Second McCullagh Affidavit, the Monitor understands:
- (i) rent payments have been issued in respect of the 27 leases subject to Lease Disclaimer Notices for the applicable 30-day disclaimer notice periods;
  - (ii) rent payments for the period from the Filing Date to January 31, 2021 have been issued in respect of five leases that expire on January 31, 2021, which the Applicants do not intend to renew; and
  - (iii) rent cheques have either been sent by courier or wire transfers have been processed to ensure that by February 1, 2021, rent payments will be paid, on behalf of the

Applicants, for each of the remaining leases for the period from the Filing Date to February 28, 2021.

Rent Reserve

3.7 As described in the Pre-Filing Report, in order to provide additional comfort to landlords that rents will be paid during the CCAA Proceedings, the Applicants have agreed to an arrangement pursuant to which the Individual Opcos will fund US\$3.1 million (the “**Rent Reserve**”), representing one month’s aggregate rent obligations of the Applicants pursuant to their respective leases (subject to certain carve-outs, as described further in the Pre-Filing Report), to be held in escrow by the Monitor for rent obligations during the CCAA Proceedings.

3.8 The Rent Reserve was funded and received by the Monitor on January 28, 2021.

Wells Fargo

3.9 As described in the Pre-Filing Report, YGC is the only Applicant that is a guarantor to the Wells Fargo Credit Facility. Wells Fargo has raised no objection to the CCAA Proceedings or borrowings to be made under the DIP Facility, though it is reserving its rights in all respects on the understanding that it will be an unaffected creditor in any plan of compromise or arrangement filed by the Applicants and that the Charges will be subordinate and junior to the Wells Fargo Credit Facility.

3.10 The Monitor understands that the Company and Wells Fargo are continuing to work to finalize the terms of a formal amendment to the Wells Fargo Credit Facility to memorialize the understanding of the parties.

#### 4.0 CHAPTER 15 CASE

- 4.1 Pursuant to the Initial Order, on January 25, 2021, the Monitor, as the foreign representative of the Applicants, filed petitions for recognition of the CCAA Proceedings under Chapter 15 in the United States Bankruptcy Court for the District of Delaware (the “**US Court**”). A hearing on the first day motions was held on January 27, 2021 before the Honorable Brendan Linehan Shannon.
- 4.2 At the first day hearing, among other things, the US Court granted an Order Granting Provisional Relief (the “**Chapter 15 Provisional Order**”) recognizing and enforcing the Initial Order in the United States on an interim basis, which among other things, provides a stay of any execution against the assets of the Applicants located in the United States and authorizes the Applicants to enter into and perform their obligations under the DIP Facility. A copy of the Chapter 15 Provisional Order is attached to the Second McCullagh Affidavit as Exhibit “A”.
- 4.3 A hearing to approve the recognition of the Initial Order in the United States on a final basis has been scheduled before the US Court for February 25, 2021, with an objection deadline of February 18, 2021.
- 4.4 All documents filed in the Chapter 15 proceedings are available at <https://cases.primeclerk.com/yatsen/>.

## **5.0 INCREASE TO THE DIP LENDER'S CHARGE**

5.1 The Initial Order provides for a DIP Lender's Charge over on the Applicants' Property in an amount not to exceed \$500,000. The Applicants are seeking an increase in the amount of the DIP Lender's Charge in the Amended and Restated Initial Order to \$5 million.

5.2 The Monitor's observations with respect to the DIP Facility are set out in Section 5.0 of the Pre-Filing Report. As discussed therein: (i) the DIP Facility is projected to provide the Applicants with sufficient financing to fund the professional and legal fees associated with the CCAA Proceedings and the Chapter 15 proceedings in order to implement the contemplated restructuring of the Applicants' business; and (ii) it is a condition of the DIP Facility that the DIP Lender's Charge be granted by this Court. The increase in the value of the DIP Facility is representative of forecast professional and legal fees for the duration of the case, given that the Applicants have no other access to funds for such costs. This value was developed by the Company, in consultation with the Monitor and applicable professionals, and represents the higher range of the forecast given that the DIP Facility is the only source of financing.

5.3 For the reasons described in the Pre-Filing Report and above, the Monitor believes that the increase to the DIP Lender's Charge is reasonable in the circumstances.

### Priority of Charges Created by the Amended and Restated Initial Order

5.4 The contemplated priorities of the Charges in the Amended and Restated Initial Order are as follows:

(i) First – Administration Charge (to the maximum amount of \$500,000); and

- (ii) Second – DIP Lender’s Charge (to the maximum amount of \$5 million).

5.5 As described above, the Charges are subordinate to the Wells Fargo Credit Facility.

## **6.0 EXTENSION OF THE STAY PERIOD**

6.1 Pursuant to the Initial Order, the current Stay Period expires on February 3, 2021. The Applicants are seeking an extension of the Stay Period to and including March 31, 2021.

6.2 The Monitor supports the requested extension to the Stay Period for the following reasons:

- (i) the extension is necessary to enable the Applicants to continue ongoing discussions and negotiations with landlords to attempt to achieve consensual lease amendments in order to make the applicable store locations viable;
- (ii) subject to the granting of the proposed increase in the DIP Lender’s Charge, the Applicants have sufficient liquidity through the requested extended Stay Period; and
- (iii) the Applicants continue to act in good faith and with due diligence in their efforts to advance the CCAA Proceedings.

## **7.0 ACTIVITIES OF THE MONITOR SINCE THE FILING DATE**

7.1 Since the Filing Date, the primary activities of the Monitor have included the following:

- (i) engaging in discussions with the Company, as well as their respective legal counsel and financial advisors regarding the CCAA Proceedings, including in connection with ongoing discussions and negotiations with landlords;

- (ii) working with the Monitor's US counsel, Young Conaway Stargatt & Taylor, LLP, and other counsel involved in the Canadian and US proceedings, to finalize the materials to commence the Chapter 15 case and attending the hearing before the US Court held on January 27, 2021;
- (iii) reviewing and approving notices for the disclaimer of 27 of the Applicants' leases and three related storage rental agreements;
- (iv) monitoring the Applicants' cash flow (there has been no cash flow activity since the granting of the Initial Order);
- (v) activating the Case Website and coordinating the uploading of Court-filed documents to the website;
- (vi) coordinating with Prime Clerk, the Monitor's US noticing agent, regarding the activation of the US docket for the Chapter 15 case and required creditor and other noticing;
- (vii) completing and coordinating the noticing requirements pursuant to the Initial Order, including:
  - (a) arranging for publication of notice of the CCAA Proceedings, in the prescribed form, in The Globe and Mail (National Edition) (January 28, 2021 and February 2, 2021) and the Wall Street Journal (January 29, 2021 and February 3, 2021);
  - (b) posting the Initial Order to the Case Website on January 25, 2021;

- (c) arranging, through Prime Clerk, for notice of the CCAA Proceedings, in the prescribed manner, to be mailed to all known creditors having a claim against the Applicants for more than \$1,000; and
- (d) preparing and posting to the Case Website on January 25, 2021, a listing of the names and addresses of all known creditors having a claim against the Applicants for more than \$1,000;
- (viii) activating the Monitor's toll-free number and email account for the CCAA Proceedings;
- (ix) submitting Forms 1 (Information Pertaining to Initial Order) and 2 (Debtor Company Information Summary) and related documents to the Office of the Superintendent of Bankruptcy's CCAA Online Filing System; and
- (x) with the assistance of its legal counsel, preparing this First Report.

## **8.0 CONCLUSIONS AND RECOMMENDATIONS**

- 8.1 For the reasons set out in this First Report, the Monitor respectfully recommends that the Court grant the Amended and Restated Initial Order containing the relief requested by the Applicants.


## 1.0 INTRODUCTION

- 1.1 Alvarez & Marsal Canada Inc. (“**A&M**” or the “**Proposed Monitor**”) understands that Yatsen Group of Companies Inc. (“**YGC**”), SAR Real Estate Inc. (“**SAR Real Estate**”) and the 36 companies listed in **Appendix “A”** (collectively, the “**Applicants**”<sup>1</sup>) intend to make an application to the Ontario Superior Court of Justice (Commercial List) (the “**Court**”) for an order (the “**Initial Order**”) granting, among other things, a stay of proceedings pursuant to the *Companies’ Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended (the “**CCAA**”), and appointing A&M as Monitor of the Applicants (the “**Monitor**”). The proceedings to be commenced by the Applicants under the CCAA are referred to herein as the “**CCAA Proceedings**”.
- 1.2 Each of the Applicants are directly or indirectly owned by Yatsen Group Inc. (“**YGI**”), a wholly owned subsidiary of Edjar International Inc. (“**EII**”). EII, collectively with its direct and indirect subsidiaries (“**Sarku Japan**” or the “**Company**”), operates approximately 226 Japanese quick service restaurants across the United States.
- 1.3 As described below, Sarku Japan’s business is comprised of two segments: (i) the real estate segment (the “**Real Estate Segment**”); and (ii) the restaurant operations segment (the “**Operations Segment**”). The Operations Segment’s parent company is SAR Holdings Inc. (“**SHI**”).

<sup>1</sup> YGC and two of the other Applicants are incorporated under the laws of Ontario. The remaining Applicants are incorporated in the United States.

- 1.4 An organizational chart showing the legal entity structure of Sarku Japan, including the Applicants, is attached hereto as **Appendix “B”**. A simplified version of the legal and operational structure is as follows:



- 1.5 Each of the Applicants are entities within the Real Estate Segment. EII, YGI and the entities in the Operations Segment are not Applicants in the CCAA Proceedings.
- 1.6 The impact of the COVID-19 pandemic on the Company’s business has been significant, including extensive government-mandated restaurant closures and a material reduction in revenue and profitability. As a result of these challenges, the Company has accrued significant rent arrears across the majority of the Applicants’ lease portfolio and, as further described below, defaulted under the Wells Fargo Credit Facility (defined below) guaranteed by, among others, YGC.
- 1.7 The objective of the CCAA Proceedings is to stabilize the Applicants’ business and to allow them to pursue a restructuring plan that includes: (i) continuing ongoing discussions with landlords in an effort to obtain sustainable lease amendments across the lease

portfolio; and (ii) the termination of leases in respect of a number of underperforming locations that the Applicants, in consultation with their advisors, have determined have no path towards viability. The Applicants are continuing to review and assess their lease portfolio in that regard.

1.8 The purpose of this pre-filing report (the “**Report**”) is to provide the Court with information, and where applicable, the Proposed Monitor’s views on:

- (i) A&M’s qualifications to act as Monitor (if appointed);
- (ii) background information with respect to the Applicants (and the Company generally);
- (iii) the DIP Facility (defined below);
- (iv) the Applicants’ 13-week cash flow forecast;
- (v) the Applicants’ cash management system;
- (vi) intended next steps in the CCAA Proceedings, including the proposed Chapter 15 proceedings;
- (vii) the priority Court-ordered charges over the property and assets of the Applicants (the “**Property**”) as well as the non-impairment of a secured guarantee provided to Wells Fargo by YGC, as sought in the Initial Order; and
- (viii) the Proposed Monitor’s conclusions and recommendations in connection with the foregoing.

## 2.0 TERMS OF REFERENCE AND DISCLAIMER

2.1 In preparing this Report, A&M, in its capacity as Proposed Monitor, has been provided with, and has relied upon, unaudited financial information, books and records and financial information prepared by the Company (including information provided by the Operations Segment's financial advisor, CR3 Partners, LLC ("**CR3**")) and has held discussions with the Company's management and its legal and financial advisors (collectively, the "**Information**"). Except as otherwise described in this Report in respect of the Applicants' cash flow forecast:

- (i) the Proposed Monitor has reviewed the Information for reasonableness, internal consistency and use in the context in which it was provided. However, the Proposed Monitor has not audited or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would wholly or partially comply with Canadian Auditing Standards ("**CASs**") pursuant to the *Chartered Professional Accountants Canada Handbook* (the "**CPA Handbook**") and, accordingly, the Proposed Monitor expresses no opinion or other form of assurance contemplated under CASs in respect of the Information; and
- (ii) some of the information referred to in this Report consists of forecasts and projections. An examination or review of the financial forecasts and projections, as outlined in the CPA Handbook, has not been performed.

2.2 Future oriented financial information referred to in this Report was prepared based on the Company's estimates and assumptions. Readers are cautioned that since projections are based upon assumptions about future events and conditions that are not ascertainable,

actual results will vary from the projections, even if the assumptions materialize, and the variations could be significant.

2.3 This Report should be read in conjunction with the Affidavit of Joseph McCullagh, President of YGC, and the President and Co-Chief Executive Officer of YGI, sworn on January 24, 2021 (the “**McCullagh Affidavit**”), and filed in support of the Applicants’ application for relief under the CCAA. Capitalized terms used and not defined in this Report have the meanings given to them in the McCullagh Affidavit.

2.4 Unless otherwise stated, all monetary amounts contained herein are expressed in Canadian dollars (“**CAD**”).

### **3.0 A&M’S QUALIFICATIONS TO ACT AS MONITOR**

3.1 Alvarez & Marsal Canada ULC was engaged to act as consultant to YGC and its subsidiaries on December 22, 2020, and as such, the Proposed Monitor is familiar with the business and operations of the Applicants, their personnel and the key issues and stakeholders in the proposed CCAA Proceedings. A&M is a trustee within the meaning of subsection 2(1) of the *Bankruptcy and Insolvency Act* (Canada) and is not subject to any of the restrictions on who may be appointed as monitor set out in section 11.7(2) of the CCAA.

3.2 A&M is related to Alvarez & Marsal Holdings, LLC which is an independent international professional services firm, providing, among other things, bankruptcy, insolvency and restructuring services. The senior A&M personnel with carriage of this matter include experienced insolvency and restructuring practitioners who are Chartered Professional Accountants (Chartered Accountants), Chartered Insolvency and Restructuring

Professionals, and Licensed Insolvency Trustees, and whom have previously acted in CCAA matters of a similar nature and complexity in Canada.

3.3 The Proposed Monitor has retained Osler, Hoskin & Harcourt LLP to act as its independent legal counsel.

3.4 A&M has consented to act as Monitor of the Applicants should the Court grant the Applicants' request to commence the CCAA Proceedings.

#### **4.0 BACKGROUND INFORMATION**

##### Overview

4.1 Extensive background information regarding the Applicants' and the Company's business generally is provided in the McCullagh Affidavit. Certain key aspects are summarized below.

4.2 Sarku Japan is a Japanese quick service restaurant chain which operates approximately 226 mall-based and street level restaurants across the United States. The Company operates five complementary banners, each with a unique brand and concept. Of the 226 locations, 185 are Company-owned and 41 are franchised<sup>2</sup>.

4.3 Although all of the Company's restaurants are located in the United States, its head office and all of its senior management are located at YGI's head office in Markham, Ontario.

---

<sup>2</sup> Of Sarku Japan's 226 restaurants: (a) 207 locations are leased by entities within the Real Estate Segment (189 of these leases are held by the Applicants); (b) seven locations are leased directly by Individual Opcos (as defined below); and (c) 12 locations are leased directly by franchisees.

4.4 The COVID-19 pandemic has had a significant detrimental impact on the Company's business, including, but not limited to the following:

- (i) commencing in March 2020, in accordance with applicable government mandates, Sarku Japan was required to close substantially all of its restaurant locations;
- (ii) as closure mandates were eased, a number of the Company's locations have remained closed. As of the date of this Report, of the Company's 226 locations, approximately 184 are open (of which, approximately 152 are subject to leases held by one of the Applicants);
- (iii) as a result of reduced sales due to the COVID-19 mandated closures and lower foot traffic in many of the re-opened locations, the Company's consolidated revenue for the twelve months ended December 2020 declined by approximately 46% compared to the same period in the prior year; and
- (iv) the deteriorated financial position of the Company resulted in certain defaults under a Wells Fargo Credit Facility during the second quarter of fiscal 2020.

4.5 Rental payments in respect of all restaurants owned by the Company had been paid in full up to and including March 2020. Since April 2020, other than approximately US\$6.4 million of rent (or partial rent) that was paid, the Company generally ceased paying rent in respect of substantially all of its leases. As at December 31, 2020, approximately 174 of the Applicants' 189 leases are in arrears, with approximately US\$26.8 million outstanding in aggregate.

4.6 In light of the above challenges:

- (i) in September 2020, CR3 was engaged by the Company to, among other things, assist the Company with a review of strategic alternatives and engage in discussions with Wells Fargo (as defined below) regarding the Wells Fargo Credit Facility; and
- (ii) in August 2020, Hilco Real Estate, LLC (“**Hilco**”) was engaged by the Company to provide certain consulting services in connection with reviewing leases and developing a strategic plan for restructuring and/or terminating leases, and negotiating and implementing such plan with applicable landlords.

4.7 YGC, with the assistance of Hilco and on behalf of the entire Real Estate Segment, has made extensive efforts to seek consensual arrangements with landlords for viable lease terms; however, the Applicants have been unable to achieve such an out-of-court resolution with the majority of their landlords. The Proposed Monitor understands that a number of landlords have commenced legal action against certain of the Applicants in multiple jurisdictions, including one in which a location was lost due to the landlord’s actions. In addition, one landlord has locked the Applicants out of seven locations, which the Applicants have not had access to since October 2020.

4.8 As described in further detail below, YGC has a negligible cash position and the remaining Applicants do not generate cash. The lease obligations of the Applicants were previously satisfied by various Individual Opcos (as defined below) and franchisees pursuant to occupancy and sublease agreements. However, following restaurant closures and the resulting financial difficulties, these Individual Opcos and franchisees generally stopped

making their applicable rent payments, as set forth in greater detail in the McCullagh Affidavit.

#### Leases & Restaurant Operations

- 4.9 Sarku Japan's business is comprised of two segments, the Real Estate Segment and the Operations Segment. The McCullagh Affidavit describes these segments in detail. A summary is provided below:

##### *Real Estate Segment*

- (i) comprised of YGC, SAR Real Estate and 57 individual entities (the “**Individual Leasecos**”) (36 of the 57 Individual Leasecos are Applicants in the CCAA Proceedings, see Appendix A);
- (ii) SAR Real Estate and the Individual Leasecos have separately entered into lease agreements with third-party landlords for the subject restaurant locations;
- (iii) after entering into a lease, SAR Real Estate or the applicable Individual Leaseco then entered into an occupancy agreement and/or sublease with an Individual Opco or the franchisee that operates the restaurant;
- (iv) for administrative efficiency, the Individual Opco or franchisee typically makes the payment in respect of the rent obligations to the applicable landlord on behalf of SAR Real Estate or the Individual Leaseco (rather than paying the amounts due to SAR Real Estate or the Individual Leaseco to then pay to the landlord);

- (v) of Sarku Japan's 226 restaurants: (a) 207 locations are leased by entities within the Real Estate Segment (189 of these leases are held by the Applicants); (b) seven locations are leased directly by Individual Opcos; and (c) 12 locations are leased directly by franchisees;
- (vi) the Real Estate Segment does not have any employees and in all material respects is managed by YGI from the Markham, Ontario headquarters;
- (vii) as at December 31, 2020, the Applicants owed approximately US\$26.8 million in rent pursuant to its 189 leases;
- (viii) YGC guarantees approximately 73 leases across the portfolio (approximately 61 of which are for leases held by an Applicant). YGC earns a guarantee fee based on a percentage of the applicable rent amounts, which fee is paid by the applicable counterparty;
- (ix) of the total rent arrears noted above, US\$8.4 million relates to those leases of the Applicants which are guaranteed by YGC;

- (x) the following table summarizes the leases, guarantees and rent arrears owing by the Applicants and non-Applicants within the Real Estate Segment:

- (xi) comprised of SHI and 58 individual entities (the “**Individual Opcos**”);
- (xii) SHI and the Individual Opcos are not Applicants and are not party to the CCAA Proceedings;
- (xiii) the Operations Segment operates the Company’s corporate-owned restaurants, holds all intellectual property, are party to franchise arrangements and provide ancillary services in respect of franchised locations;
- (xiv) the Operations Segment is funded from cash flow generated by operating the restaurants and from the Wells Fargo Credit Facility;
- (xv) the Operations Segment is managed by YGI in Canada from the Markham, Ontario headquarters, including, among other things, making all key business and strategic

decisions, negotiating and entering into key supplier arrangements, and providing accounting, bookkeeping, IT and other services to the Individual Opcos; and

- (xvi) the Company also has a number of franchise arrangements with third-party franchisees; in respect of these franchised locations, the Operations Segment provides various services pursuant to franchise agreements.

#### Unsecured Creditors

- 4.10 Other than the amounts owing for rent arrears discussed above (and associated guarantees), the Applicants' books and records reflect that no other amounts are owing to any third-party creditors.

#### Rent Payments

- 4.11 As described above, the Applicants are party to 189 leases. Pursuant to these leases, SAR Real Estate and the 36 Individual Leasecons, as applicable, are obligated to make rent payments to the applicable landlord. On a combined basis, rent for these 189 locations is approximately US\$3.6 million per month.
- 4.12 The leases to which the non-Applicant entities are a party will not be affected by these CCAA Proceedings and will continue pursuant to their existing terms, as will the related occupancy agreements or subleases.
- 4.13 Pursuant to the applicable occupancy and/or sublease agreements, each Individual Opco or franchisee is contractually obligated to pay the applicable rent amount on behalf of SAR Real Estate or the Individual Leaseco, as applicable, for the leased locations.

- 4.14 As described in the McCullagh Affidavit, the Individual Opcos and franchisees have historically paid rent directly to the applicable landlord on behalf of SAR Real Estate or the Individual Leaseco. The Proposed Monitor understands that during the CCAA Proceedings this practice will continue. The Company has provided the Proposed Monitor with confidential information that shows, to the satisfaction of the Proposed Monitor, provision for the full payment of rent owing by the Applicants during the CCAA Proceedings by the Individual Opcos, provided that Wells Fargo does not take any enforcement actions with respect to the defaults under the Wells Fargo Credit Facility.
- 4.15 In order to provide additional comfort to landlords that rents will be paid in accordance with the leases during the CCAA Proceedings, the Applicants have agreed to an arrangement pursuant to which the applicable Individual Opcos will fund, in aggregate, US\$3.1 million (the “**Rent Reserve**”), to be held by the Monitor in escrow as security for the payment of rent obligations incurred from and after the commencement of the CCAA Proceedings. The escrow agreement (the “**Escrow Agreement**”) pursuant to which the Rent Reserve will be deposited and administered (subject to the proposed Initial Order) is appended as Exhibit “E” to the McCullagh Affidavit.
- 4.16 The amount of the Rent Reserve is equal to the sum of the forecast rent obligations of the Applicants for the one-month period following the commencement of the CCAA Proceedings, excluding rent obligations for the 30-day notice period applicable to leases the Applicants intend to disclaim promptly after obtaining the proposed Initial Order and payments for leases expiring at the end of this month which the Applicants do not intend to renew. The Applicants understand that the Individual Opcos will pay rent obligations on their behalf for such disclaimer notice period in accordance with the proposed Initial Order

and to pay rent for the “stub” period between filing and January 31, 2021 prior to the proposed comeback hearing.

- 4.17 In the event any Individual Opco or franchisee fails to pay its monthly rent following the commencement of the CCAA Proceedings (e.g. post-filing period rent), YGC, on behalf of the applicable Applicant, will have the ability to direct the Monitor to pay the applicable lease payment from the Rent Reserve on behalf of SAR Real Estate or the applicable Individual Leaseco, subject to the terms of the Escrow Agreement.

Wells Fargo Credit Facility

- 4.18 SHI (a non-Applicant entity) is the borrower under the Credit Agreement with Wells Fargo Bank, National Association, as administrative agent (“**Wells Fargo**”) and the various lenders party thereto (the “**Wells Fargo Credit Facility**”). The facility is guaranteed by Edjar Food Group Inc., EII, YGI and YGC (the only Applicant guarantor), among others. The facility is a US\$70 million revolving credit facility, of which approximately US\$50 million had been drawn as at December 31, 2020. The Wells Fargo Credit Facility is described in further detail in the McCullagh Affidavit.
- 4.19 The Proposed Monitor understands that Wells Fargo has raised no objection to the commencement of the CCAA Proceedings or borrowings to be made under the DIP Facility, though it is reserving its rights in all respects and on the understanding that it will be an unaffected creditor in any plan of compromise or arrangement filed by the Applicants in the CCAA Proceedings and that the Charges (as defined below) will be subordinated to security granted by YGC. The Monitor understands that the parties to the Wells Fargo Credit Facility are in the process of settling a formal amendment with respect to same.

4.20 The Applicants are seeking that the Initial Order provide that Wells Fargo shall be treated as unaffected in any plan of arrangement under the CCAA or any proposal filed by the Applicants under the *Bankruptcy and Insolvency Act* with respect to any claims against YGC under its secured guarantee of the Wells Facility. Furthermore, as described below, the court ordered charges are proposed to rank behind such security.

4.21 In connection with the above-noted relief being sought in the proposed Initial Order, the Proposed Monitor's counsel has conducted a review of the security granted by YGC to Wells Fargo pursuant to its guarantee of the Wells Fargo Credit Facility. Subject to qualifications and assumptions customary in rendering security opinions of this nature, the Proposed Monitor's counsel is of the view that such security is valid and enforceable security perfected by registration in the province of Ontario, to the extent capable of perfection by registration of a financing statement under the Ontario *Personal Property Security Act*. The Proposed Monitor's counsel expects to prepare a security opinion setting out their conclusions with respect to the security, which the Proposed Monitor will make available to this Court on request.

## **5.0 DIP FACILITY**

5.1 As described in the McCullagh Affidavit, the Applicants require financing to fund the professional and legal fees associated with the CCAA Proceedings and the Chapter 15 proceedings and to implement the contemplated restructuring of the Applicants' business. As noted above, the Applicants do not generate or hold any cash. Accordingly, financing will be required upon the commencement of the CCAA Proceedings.

5.2 The Applicants have been offered financing from 1699803 Ontario Inc. (in such capacity, the “**DIP Lender**”), an entity owned by the equity holders of the Company, pursuant to a secured debtor-in-possession credit facility (the “**DIP Facility**”). The DIP Facility is described in detail in the McCullagh Affidavit. Key terms of the DIP Facility include the following:

5.3 The Proposed Monitor is of the view that the DIP Facility is reasonable in the circumstances. The Proposed Monitor notes the following:

- (i) the amount of the DIP Facility requested to be approved pursuant to the Initial Order (\$500,000) is projected to provide the Applicants with sufficient liquidity during the first ten days of the CCAA Proceedings to pay the costs of necessary professional advisors who, as described further herein, will only have a limited and subordinated Administration Charge (as defined below) against the Applicants, which do not generate or hold cash;
- (ii) the DIP Facility should not financially prejudice the Applicants' limited creditor pool, given: (a) the protections to be afforded to the various landlords in the proposed Initial Order (as described further herein, including the Rent Reserve); (b) that it is intended that the landlords will receive all post-filing rent amounts owing in the ordinary course; and (c) the proposed prohibition on Wells Fargo being affected in any plan of arrangement or proposal; and

- (iii) at 3% interest and no fees, the DIP Facility provides favourable pricing and terms compared to other similar related-party DIP facilities approved by the Canadian courts in other CCAA proceedings, which is particularly relevant in light of the limited asset base of the Applicants and the priority treatment to be afforded to Wells Fargo described herein.

## 6.0 CASH FLOW FORECAST

- 6.1 The Applicants have prepared a weekly cash flow forecast (the “**Cash Flow Forecast**”) for the 13-week period from January 25 to April 24, 2021 (the “**Cash Flow Period**”). A copy of the Cash Flow Forecast, together with a summary of assumptions (the “**Cash Flow Assumptions**”) and Management’s report on the cash-flow statement required by section 10(2)(b) of the CCAA are attached hereto as **Appendices “C”** and “**D**”, respectively.
- 6.2 As summarized in the table below, during the Cash Flow Period, the Cash Flow Forecast shows negative net cash flows of approximately \$2.1 million.

- 6.3 The Proposed Monitor notes the following with respect to the Cash Flow Forecast:
- (i) as at the date of this report, the Applicants have a negligible cash balance, which will not change during the course of the CCAA Proceedings;

- (ii) other than professional fees, the Applicants' do not have any other disbursements forecast during the Cash Flow Period; and
- (iii) as described in paragraphs 4.11 through 4.17 of this Report, consistent with past practice, all rent obligations owing by the Applicants during the CCAA Proceedings will be paid directly by the Individual Opcos and franchisees pursuant to the occupancy agreements or subleases.

6.4 Based on the Proposed Monitor's review<sup>3</sup>, nothing has come to its attention that causes it to believe, in any material respect that:

- (i) the Cash Flow Assumptions are not consistent with the purpose of the Cash Flow Forecast;
- (ii) as at the date of this Report, the Cash Flow Assumptions are not suitably supported and consistent with the plans of the Applicants or do not provide a reasonable basis for the Cash Flow Forecast, given the Cash Flow Assumptions; or
- (iii) the Cash Flow Forecast does not reflect the Cash Flow Assumptions.

The Cash Flow Forecast has been prepared solely for the purpose and subject to the assumptions described above, and readers are cautioned that it may not be appropriate for

<sup>3</sup> The Proposed Monitor has reviewed the Cash Flow Forecast to the standard required of a Court-appointed Monitor by section 23(1)(b) of the CCAA. Section 23(1)(b) requires a Monitor to review the debtor's cash flow statement as to its reasonableness and to file a report with the Court on the Monitor's findings. Pursuant to this standard, the Proposed Monitor's review of the Cash Flow Forecast consisted of inquiries, analytical procedures and discussions related to information supplied to it by certain key members of management. The Proposed Monitor reviewed information provided by management for the Cash Flow Assumptions. Since the Cash Flow Assumptions need not be supported, the Proposed Monitor's procedures with respect to them were limited to evaluating whether they were consistent with the purpose of the Cash Flow Forecast.

other purposes. The Cash Flow Forecast is subject to material change in the event that the Applicants are not able to negotiate acceptable rent arrangements with their landlords.

## **7.0 CASH MANAGEMENT SYSTEM**

7.1 As described in the McCullagh Affidavit, the Applicants have banking relationships with CIBC and TD Bank in Canada, and Wells Fargo in the United States. The Applicants' cash management system (the "**Cash Management System**") is operated through various bank accounts denominated in both US and Canadian dollars and held by the individual Applicants at CIBC and TD Bank, each in Markham and Toronto, respectively, and Wells Fargo in California. The Applicants are part of an integrated, centralized cash management system with Sarku Japan's other entities (the "**Cash Management System**"). The Cash Management System is administered by Sarku Japan's treasury department at the head office in Markham, Ontario.

7.2 The activity through the Applicants' Cash Management System and associated bank accounts is relatively minimal. For administrative efficiency, the Individual Opco or franchisee typically makes the payment in respect of the rent obligations to the applicable landlord on behalf of SAR Real Estate or the applicable Individual Leaseco (rather than paying the amounts due to SAR Real Estate or the Individual Leaseco to then pay to the landlord). Similarly, where applicable, the Individual Opco or the franchisor makes the payment in respect of any applicable lease guarantee fee directly to YGC.

7.3 The Applicants intend to continue using their existing Cash Management System in substantially the same manner as before the commencement of the CCAA Proceedings and are seeking the approval of Court to do so. The Proposed Monitor supports this request.

## **8.0 CHAPTER 15 PROCEEDINGS**

8.1 As discussed in the McCullagh Affidavit, the Applicants intend to seek recognition of the these CCAA Proceedings under Chapter 15 of the United States Bankruptcy Code and authorization for the Proposed Monitor to apply as foreign representative for the recognition of these proposed CCAA Proceedings as “Foreign Main Proceedings”.

## **9.0 INTENDED NEXT STEPS IN THE CCAA PROCEEDINGS**

9.1 The Proposed Monitor understands that, subject to obtaining the proposed Initial Order, the Applicants intend to:

- (i) deliver 30-day lease disclaimer notices for approximately 27 leases that have been identified as unviable following the Applicant’s analysis of same, in consultation with their advisors, subject to the Monitor’s approval; and
- (ii) continue ongoing discussions and negotiations with landlords to achieve consensual lease amendments to make such leases viable, failing which disclaimer of same may be required.

9.2 The Proposed Monitor understands that, in light of the Applicants’ liquidity position, the various legal actions commenced by certain of its landlords and the significant uncertainties with respect to the current operating environment, it is imperative that the Applicants complete their restructuring initiatives on a highly expedited timeline.

## **10.0 COURT-ORDERED CHARGES SOUGHT IN THE INITIAL ORDER**

10.1 The Proposed Initial Order seeks the granting of the Administration Charge and the DIP Lender's Charge (collectively, the "**Charges**") over the Property of the Applicants, as described below.

10.2 As described in the McCullagh Affidavit, the Charges are proposed to rank behind the security provided by YGC pursuant to its guarantee of the Wells Fargo Facility.

### Administration Charge

10.3 The Initial Order provides for a charge over the Applicants' Property in an amount not to exceed \$500,000 in favour of the Monitor, counsel to the Monitor and counsel to the Applicants (the "**Administration Charge**").

10.4 The Proposed Monitor assisted the Applicants in the calculation of the Administration Charge and is of the view that the amount of the charge for the initial 10-day stay period is reasonable and appropriate in the circumstances, having regard to the nature of the proceedings, potential work involved at peak times, and the size of charges approved in similar CCAA proceedings.

### DIP Lender's Charge

10.5 The Initial Order provides for a charge on the Applicants' Property as security for the outstanding obligations under the DIP Facility (the "**DIP Lenders' Charge**").

- 10.6 It is a condition of the DIP Facility that the DIP Lender's Charge be granted by this Court. The Monitor's observations with respect to the DIP Facility are set out in paragraph 5.0 above.

Priority of Charges Created by the Proposed Initial Order

- 10.7 The priorities of the Charges are proposed to be as follows:
- (i) First – Administration Charge (to the maximum amount of \$500,000); and
  - (ii) Second – DIP Lenders' Charge (to the maximum amount of \$500,000).
- 10.8 As set out above, the Proposed Monitor believes that the Charges are reasonable in the circumstances.

**11.0 CONCLUSIONS AND RECOMMENDATIONS**

- 11.1 For the reasons set out in this Report, if the Court is satisfied that the Applicants are companies to which the CCAA applies, the Proposed Monitor is of the view that the relief requested by the Applicants in the proposed Initial Order is reasonable, appropriate and necessary having regard to the current circumstances of the Applicants. As such, the Proposed Monitor supports the Applicants' application for CCAA protection and respectfully recommends that the Court grant the Initial Order containing the relief requested by the Applicants.


